### Dear Candidates & Treasurers:

Due to a policy change at the Office of Campaign & Political Finance, only candidates whose names appear on the preliminary ballot will be required to file a Pre-Preliminary Campaign Finance Report. This will include all School Committee candidates and candidates for Ward-2 Councillor only. (See attached)

As a reminder for those of you required to file, your Pre-Preliminary Election Campaign Finance Report is due by Monday, September 9, 2013 at 5:00 pm. Your report should cover the period from the day following the ending date of the last report filed through August 30, 2013.

**IMPORTANT:** The campaign finance law mandates that a CIVIL

PENALTY OF \$25 PER DAY, UP TO \$5,000 TOTAL, be assessed personally against a candidate for any report that is filed after the due date and upon referral to the Office of Campaign and Political Finance. In addition, failure to file the report as required will subject you to referral to the Attorney General.

Subject: Pre-preliminary campaign finance reports

The Sept./Oct. preliminary elections will begin soon, so we want to remind you of OCPF's policy change when determining who has to file a pre-preliminary campaign finance report.

Pre-preliminary campaign finance reports are only due for candidates whose name appears on a preliminary ballot. If a candidate does not appear on the preliminary ballot, he or she will not file a pre-preliminary report.

For example, if there is a preliminary election for city-wide school committee in a city, but no preliminary election for city council at large, only the school committee candidates would file pre-preliminary reports. All candidates will file pre-election reports for the Nov. 5 general election. You should note that the pre-election reports will have different beginning dates depending on whether a pre-preliminary report is filed.

Example: The preliminary election will be held on September 17. There are 6 wards in the City. A) Wards 1-5 have 2 candidates or less running for the seat. The Ward 6 seat has 4 candidates. B) There are 5 at large council seats available. There are only 9 candidates for the 5 seats. C) There are 6 School Committee seats available. 15 candidates are running for the 6 seats.

Reports are due as follows.

- A) Candidates in Wards 1-5 do not have to file a pre-preliminary since they will not be on a preliminary ballot. They will file a pre-election report with a beginning date of 1/1/13 and an ending date of 10/18/13. Their pre-election report is due October 28. The Ward 6 candidates, however, will file a pre-preliminary report because their name will appear on the preliminary ballot. The report will be due on September 9. Dates covered are 1/1/13 through 8/30/13. They will then file a pre-election report from 8/31/13 10/18/13, due October 28.
- B) No pre-preliminary report is due because there is no preliminary ballot for these seats. The preelection report dates will be 1/1/13 - 10/18/13. The report is due October 28.
- C) School Committee candidates will file a pre-preliminary report beginning on 1/1/13 and ending on 8/30/13. It will be due September 9. The pre-election report covers 8/331/13 10/18/13 and is due October 28.
