That the sum of \$364,000 appropriated for the removal of solid waste disposal facilities to be borrowed under the provisions of Massachusetts General Laws, Chapter 44, Section 8, Clause 21, as authorized by Council Order #31125 dated June 29, 2005, be hereby rescinded and given a first reading.
