Committee of the Whole

Minutes of the Meeting February 20, 2024

- 1. Vice-President LaCava called the meeting to Order at 8:00pm in the City Council Chamber.
- 2. Vice-President LaCava requested that a roll call be taken to record the attendance for the meeting. The COW Clerk called the roll Councillors Bradley-MacArthur, Brasco, Dunn, Durkee, Hanley, Harris, Katz, LaFauci, LeBlanc, Logan, President McLaughlin, McMenimen, Stanley, Vidal, and Vice-President LaCava were all present in-person.
- 3. President McLaughlin moved to approve the minutes of the COW meeting held on February 5, 2024. The motion was adopted on a voice vote and the minutes of the meeting on February 5, 2024 were approved.
- 4. A request was received from the Mayor to confirm the appointment of John B. Cervone as an Assistant City Solicitor in the Law Department. It was noted that Mr. Cervone was not present. Councillor Brasco moved to table the matter. The motion was adopted on a voice vote.
- 5. A request was received from the Mayor to confirm the appointment of Katherine D. Laughman as the City Solicitor for a 3-year term ending on February 28, 2027. Councillor Hanley spoke of Attorney Laughman's extensive background and experience. Councillor Hanley moved to hear from Attorney Laughman. The motion was adopted on a voice vote. Upon questions from Councillor Hanley, Ms. Laughman spoke of her experience as a partner at KP Law and more recently as an Assistant City Solicitor in the City's Law Department. Councillor Hanley moved approval of Attorney Laughman's appointment as the City Solicitor. On the motion, Councillors Bradley-MacArthur, McMenimen, Logan, Brasco, LaFauci and President McLaughlin asked several follow up questions and expressed their support. The motion of Councillor Hanley was adopted on a roll call vote of 15 in favor (Bradley-MacArthur, Brasco, Dunn, Durkee, Hanley, Harris, Katz, LaFauci, LeBlanc, Logan, President McLaughlin, McMenimen, Stanley, Vidal, and Vice-President LaCava) and none opposed.
- 6. The next items on the agenda all pertained to the property located at 190 Trapelo Road within Parcel 1 and Parcel 2A-1 (Council Docket of 2/12/2024 attached for reference). Councillor McMenimen recused herself from the discussion and vote due to the proximity of her residence to the property.
- 7. Vice-President LaCava explained nine of the items were to retain the naming of the existing buildings on the property. Vice-President Lacava stated that seven of the items appeared on the agenda and two of the items were left off, but did appear on the COW docket and were properly before them. President McLaughlin moved to approve the name retention of the following items #19, #20, #22, #23, #24, #25 and #27. The motion was adopted on a roll call vote of 13 in favor (Bradley-MacArthur, Brasco, Dunn, Durkee, Hanley, Harris, Katz,

- LaFauci, LeBlanc, Logan, President McLaughlin, Stanley, Vidal), McMenimen recused and Vice-President LaCava presiding.
- 8.. President McLaughlin moved to approve the name retention of the following items #21 and #26. The motion was adopted on a voice vote.
- 9. President McLaughlin moved to approve the name change of item #28 Cottage Complex to Baldwin Pond. The motion was adopted on a voice vote.
- 10. President McLaughlin moved to approve the name change of item #29 Cherry Lane to Tauro Way. The motion was adopted on a voice vote
- 11. President McLaughlin moved to approve the name change of item of #30 Administration Building to Administration Building with the inclusion of former superintendents Dr. Samuel Fridley Howe, Dr. Edward Jarvis and Dr. Walter E, Fernald. The motion was adopted on a roll call vote of 12 in favor (Brasco, Dunn, Durkee, Hanley, Harris, Katz, LaFauci, LeBlanc, Logan, President McLaughlin, Stanley, Vidal), 1 opposed (Bradley-MacArthur), McMenimen recused and Vice-President LaCava presiding.
- 12. President McLaughlin moved to file item #31 environmental study. The motion was adopted on a voice vote.
- 13. President McLaughlin moved to file item #32 archeological study. Councillor Bradley–MacArthur moved to table the matter. The motion did not pass on a roll call vote of 1 in favor (Bradley–MacArthur), 12 opposed (Brasco, Dunn, Durkee, Hanley, Harris, Katz, LaFauci, LeBlanc, Logan, President McLaughlin, Stanley, Vidal), McMenimen recused and Vice–President LaCava presiding. The motion to file the matter was approved on a roll call vote of 12 in favor (Brasco, Dunn, Durkee, Hanley, Harris, Katz, LaFauci, LeBlanc, Logan, President McLaughlin, Stanley, Vidal), 1 opposed (Bradley–MacArthur), McMenimen recused and Vice–President LaCava presiding.
- 14. President McLaughlin moved to file item #33 historical information on 190 Trapelo Road. The motion was adopted on a voice vote.
- 15. President McLaughlin moved to approve item #34 recommendations regarding the uses of Parcel 1 and Parcel 2A–1 at 190 Trapelo Road. President McLaughlin moved to hear from Recreation Director Kim Hebert to discuss and answer questions pertaining to item #34. The motion was adopted on a voice vote. Ms. Hebert identified the buildings as contributing/non–contributing. Ms. Hebert further stated that an historic architect would be engaged to determine which buildings could be retained and used. Councillor Bradley–MacArthur asked several follow up questions about specific buildings including the intended uses that are being considered. Councillor Logan asked several questions about the cost to demolish/renovate, the cost to maintain/operate and staffing costs. Ms. Hebert reiterated the need for the historic architect to first perform an evaluation of the buildings. Councillor Logan again expressed his concern about the need for financial information and if we are

"putting the cart before the horse". Councillors LeBlanc, Dunn and LaFauci asked questions about the evaluation of the buildings and if the scope would include infrastructure improvements. Councillor Katz asked Ms. Hebert to give a summary of her background and experience to manage the recreation programs under consideration. Councillor Bradley-MacArthur raised concerns about the evaluation of the proposed programs, areas for improvement, and community input. Councillor Bradley-MacArthur moved to request that a Citizen Input Hearing on the matter approved on 2/20/2024 regarding demolition and use of the 120 acres & subsequent matters related to 190 Trapelo Road on the docket dated 2/20/2024. The motion was adopted on a roll call vote of 10 in favor (Bradley-MacArthur, Brasco, Dunn, Hanley, Harris, Katz, LaFauci, LeBlanc, Logan, Stanley), 3 opposed (Durkee, President McLaughlin, Vidal), McMenimen recused and Vice-President LaCava presiding. Councillor Bradley-MacArthur stated she would submit a resolution requesting a site visit. Councillor LeBlanc stated the evaluation by the historic architect was a preliminary first step. Councillor Logan reiterated there was no commitment, just fact finding, but a need for a master plan and overall cost. Councillor Durkee expressed frustration over the statements about the lack of public input, citing there have been lots of public input meetings held, with opportunities to make recommendations, but ultimately it is a decision of the Executive Office. Councillor LaFauci moved the question. The motion was adopted on a roll call vote of 12 in favor (Brasco, Dunn, Durkee, Hanley, Harris, Katz, LaFauci, LeBlanc, Logan, President McLaughlin, Stanley, Vidal), 1 opposed (Bradley-MacArthur), McMenimen recused and Vice-President LaCava presiding. The motion of President McLaughlin was adopted on a roll call vote of 12 in favor (Brasco, Dunn, Durkee, Hanley, Harris, Katz, LaFauci, LeBlanc, Logan, President McLaughlin, Stanley, Vidal), 1 opposed (Bradley-MacArthur), McMenimen recused and Vice-President LaCava presiding.

- 16. President McLaughlin moved to table the matter of item #35 temporary easement for the MWRA. The motion was adopted on a voice vote.
- 17. President McLaughlin moved to table the matter of item #36 additional list of buildings in Parcel 2A-2 and Parcel 2B purchased with CPA funds and Parcel 3A and Parcel 3B purchase with non-CPA funds. The motion was adopted on a voice vote.
- 18. Councillor Harris moved to take the matter of the special permit process (1/22/2024) from the table. The motion was adopted on a voice vote. Councillor Harris gave a brief statement about the changes. Councillor Harris moved to approve the two script changes (attached for reference) to the special permit process. The motion was adopted on a roll call vote of 12 in favor (Bradley–MacArthur, Brasco, Durkee, Hanley, Harris, Katz, LaFauci, Logan, President McLaughlin, McMenimen, Stanley, Vidal), I opposed (Dunn), 1 absent (LeBlanc) and Vice–President LaCava presiding. Councillor Harris moved to approve the resolution (attached for reference) for the special permit process. The motion was adopted on a voice vote.
- 19. A motion by President McLaughlin to adjourn was adopted on a voice vote, and Vice-President LaCava declared the meeting adjourned at 9:50pm.
