- 1. Please provide any additional confirmation of the legal name of the owner of the Church and its lands such that would assure that an eventual Agreement with the City would provide protection of its investment of the CPA funds.
- 2. Please provide a letter of authority from the owner(s) of the Church that you were authorized to act on their behalf to apply for the funds requested. Further, provide an authorization from the owners that you are authorized to represent the Church to obtain construction bids for the purposes of the Application, and to sign such and the City Agreement.
- 3. Under the goal of the Application, the roof is mentioned and certain work including the tower. If there are any structural components which support the roof which need repair or replacement they should be addressed here. If the alternatives of using slate again versus other types of shingles such as the Grand Manor asphalt shingles were discussed that would be helpful.
- 4. The designation as listed on the National Register of Historic places is very significant. If you would provide a copy of that designation and any other listing such as the Massachusetts Register, or that of the Waltham Historical Commission as an historical icon of importance to the City, those would be important.



The City Building Department also has inspectors for all work to assure compliance with regulations.
- 9. Competitive bids are desirable.
- 10. Other sources of funds are available for historic preservation. Please detail efforts to obtain other sources of funding using CPA funds as leverage.

The Steeplecock Weathervane The First Congregational Church of Waltham, Massachusetts

The old rooster lay in a Waltham, Massachusetts cellar for a quarter of a century while the gentleman who owned it pondered the problem: to whom should he give an old Puritan rooster? Were the Unitarians or the Congregationalists truer descendants of the cock's first owner-the Puritan parish in Waltham?

The first humble meetinghouse built in 1720 was replaced in 1767 by a weathercock-topped meetinghouse which stood until 1840. The rooster, salvaged when that building was demolished, stood for a while atop a barn and then disappeared. About 1898, Charles F. Stone, the gentleman who later would deliberate upon the genealogy of religious societies, found what he felt certain to be Waltham's missing vane in the Wayside Inn, Sudbury, Massachusetts. The inn, made famous by Longfellow's tales, was then owned by an antique dealer. Mr. Stone bought the rooster and, returning it to its home town, placed it in his cellar.

Twenty-six years later, Mr. Stone decided to give the vane to The First Congregational Church of Waltham, which seemed to him the lineal descendant of the first parish, although the church which retained the name, "First Parish in Waltham," was the Unitarian Church.

Unitarians noted that the Congregational Society had been formed in 1820 while the rooster was still on its original perch. But Mr. Stone called churches as he saw them.

Shortly after the rooster was raised to its spire top, the Congregational Church was partially destroyed by fire. "The ancient bird on top of the steeple" was blamed for the burning. An anonymous letter writer to the local paper called it "A Jinx." The donor was denounced for his ill-advised gift.


Perhaps when the Unitarians saw what an ill wind blew this weathervane, they were less disturbed by Mr. Stone's decision. At any rate, resentment was assuaged when another historic vane was given to the Unitarians....

Paul Revere did not make the Waltham weathercock. It is described as follows:

Weathercock. Copper, gilded. Large, about 4'4". Made by Thomas Droune in 1767 for the First Parish, Waltham, Massachusetts. On the spire of The First Congregational Church of Waltham, Massachusetts.

(from Myrna Kaye's Yankee Weathervanes. E.P. Dutton and Company, Inc., 1975.)

This weathercock was on the steeple of the old church at Lyman and Beaver streets, for about 70 years until 1841. It was placed on the steeple of the First Congregational Church in Waltham Mass. in 1924.



This weather COCK was on the steeple of the CAB courch of Lyman and Beaver Streets for about 10 years, with 1841.

construction of new factories and expansions of existing plants like the BMC (1873, 1880, 1890, 1901-1911) and Waltham Watch (1888, 1903, 1913).

Major commercial growth continued at Central Square (Area A) and upper Moody Street (Area B) with small-scale neighborhood shopping areas developing elsewhere. It took the form of multi-story masonry blocks until late in the period when one-story blocks came into fashion.

Major public and private institutional growth occurred during this period as well. Construction of municipal buildings began with Waltham's incorporation as a city. These included the Romanesque Revival Lexington Street Fire Station,25 Lexington Street (1887; Area A), the adjacent Police Station,23 Lexinton Street (1890; Area A), and Fire Department Headquarters, 583 Moody Street (1890; #43), as well as the Waltham High School, 55 School Street (1902; #93) and the Royal Robbins School, 58 Chestnut Street (1901; #45). The most important civic building of the period was the Georgian Revival-style City Hall, 610 Main Street (1924-26; Area A) adjacent to the Common. The Common itself was graced with several statues.

The large number of churches constructed or remodeled during this period reflects both population growth and diversity. Nineteenth century examples include Beth Eden Baptist Church, 82 Maple Street (1888-1891; #44), serving the South Side and Christ Episcopal, 750 Main Street (1897-1898; #107), in Waltham Center. St. Charles Borromeo, Hall and Cushing Streets (1915-1922; #48), was built on the South Side in the 20th century while in the center, the First Congregational Church,730 Main Street (1870-71/1925; #105) was remodeled in 1925, and the old First Parish Church, 87 School Street (#100) was rebuilt in 1932-1933 following a major fire.

Finally, large parts of northern Waltham were reserved as open space during this period. On the Weston line, Stony Brook and Hobbs Brook were dammed in 1887 and 1897 to create Hobbs Brook Basin. This major water supply for the City of Cambridge dominates northern Waltham west of Route 128 (I-95). To the east, establishment of several institutions during this period has also preserved a great deal of open space. From east to west on Trapelo Road, these include the Metropolitan District Commission's Beaverbrook Reservation, the Fernald State School (1887), Metropolitan State Hospital (1930), and Middlesex County Hospital (early 20th century). Bentley College on Forest Street extends the open space further. Brandeis University serves the same function in southeast Waltham. It was founded in 1948 by the Jewish community, and named in honor of Louis Brandeis, the first Jewish Supreme Court justice.




