UPCOMING PROJECTS/OTHER ISSUES

DSC Commission Secretary, Pamela Jones reported the damaged curbing on Lexington and Dale Streets, in the front of Ryan's Wine Shop still has not been repaired. She will forward a reminder to Mike Chiasson at the Department of Public Works.

The Commission had received a photograph with a complaint from a citizen of a HP Parking Space near the gym at Waltham High School that was badly in need of repair. Pamela Jones contacted John Pinzone of the School Department and Mr. Pinzone promptly had the necessary repairs completed on the space and requested we contact the Public Works Department to request a new HP Parking sign installed and the lining of the HP space completed. Pam Jones will forward a letter to Mr. Chiasson to request this work be done as soon as it is possible as the colder weather will be approaching soon, along with a reminder of the curbing repair needed at Lexington and Dale Street.

Chairperson, Mark Johnson also informed the Commissioners all Minutes of the Disability Services Commission are maintained on the hard drive on a computer used by Mr. Johnson rather than maintaining printed hard copies as was done previously.
