Tracing PV billing-credits - Eileen

• Eileen said she will talk to Joe Pedula about how are we doing with optimizing returns back from the PV installation. She said there are some discrepancies in understanding among Tony, Andy, and Gerry.

Possible sources and/or assistance for funding the refrigeration upgrades that will result in substantial reduction in energy use at the ice rink – Leo

Leo said leads so far haven't resulted in contact with people who are knowledgeable about this. He will check with Tony.

Northeast Elementary School update - Amy

Amy said her goal of envisioned presentations at Northeast Elementary is for students to go home and talk up energy conservation.

- Nadene Stein (School Principal) was the initial contact on this project.
- Amy was referred to the "Science Coordinator" who proposed a presentation on energy to 4th grade. Amy checked for existing curricula and found only one (from San Francisco).

There are a lot of courses, but not curricula.

Maybe this has to be limited to energy conservation.

- Not for instance, why people should conserve energy
- Nadine didn't know the panels on the Northeast Elementary School are now turned on.
- Bob noted that NStar will do a presentation on energy.

Green Communities Update - Kathy

Joanne Bissetta (Regional State GC Coordinator) said the next application period is fall '13.

- Melissa suggested checking with local businesses.
- Bob suggested checking with NGrid and NSTAR (if we have a project lined up they will respond). Kathy mentioned Mass Save, NSTAR, and NGrid may not be responsive because they are upset about non action on the Municipal Center audit. Also, another auditor may provide a higher grade audit.
- It was decided to hold until we get the NSTAR and NGrid situation ironed out.
