Green Communities updates - what will it take to get there?

- Rick focused in on Criterion 3 showing reference list and the *Guidance for Criterion 3* and referring to a sample Criterion 3 Action Plan.

Janna handed out Guidence for Criterion 4 (fuel efficient vehicles)

• A significant aspect is that requirements evolve (generally become stricter) so each time a vehicle is purchased the most recent requirements have to be met.

Janna also thought our vehicle plan should be more comprehensive and include provisions to truly reduce motor vehicle impact (drive less, for example).

Janne mentioned Green Commute Day at Brandeis (day after earth day)

Kathy suggested we could put city's fuel efficient vehicles on the web site

Eileen: maybe we should email guy and tell him he's been volunteered.

• Eileen:

John Tasjian (Director of Public Vehicles) supports green policies. Waltham is the first Massachusetts city to adopt a program to recycle used motor oil from public vehicles.

- Rick handed out copies of Steve's letter.
- Andy felt even Steve's note might look a bit like we're looking over the shoulders of City officials and administrators and possibly being prescriptive. Maybe we can ask them to attend a meeting. Maybe we can stop in and talk.
- Janna thought a phone call might be better than asking for paper. Maybe we can offer option of phone call. Also, the depth of answers to all the questions is unclear. Maybe we can do a few daytime meetings to involve people who would like to attend a meeting but would prefer that time rather than evenings. Also response can be email. Also, maybe we should remove the third bullet asking energy specifics. People generally agreed.
- Eileen: There was, the 2008 Inventory (Waltham's Energy use and Emissions of Greenhouse Gases 2005-2007 by Jake Yarmus) and now WEAc is asking similar questions, possibly creating the impression that this information goes nowhere and does nothing. Maybe we can refer to the Inventory and say we're building on that. Maybe Andy could ask Skip how we should contact Department heads. Eileen asked: What do we really want in response to letter?

Rick, said we want baseline information (KWHr, gal of gas, etc)

Kathy said relationship building is first.

Pat suggested we do have to build more bridges (like Andy's link w/ Skip Bandini)

Pat: Soften letter, send it out, follow up with phone call or visit.

Rick and Kathy will work on the letter (Steve posted a copy on the Google site). Pat: goal is to send letter out by next week.

# WATCH proposal:

Andy refered to the Barnraising & Education for Waltham Energy Lowering (BE WEL) project summary, 01-Mar-10 from WATCH CDC. WATCH asked if we would partner with them. We offered support as noted in last minutes.

• Andy noted there was no mention of MassSave in the original proposal and it turns out that Erica Schwarz (project contact) wasn't aware of the opportunity and thought it made sense to engage MassSave as part of the plan. So the plan has evolved. For example, the WATCH program will handhold people through the MassSave process.

• Janna Has become aware of Dwight Peavey (state EPA scientist) who is working with city for one thing to keep city from being sued over environmental issues. He meets with all Waltham dept. heads. He actually has power to sue the City. This group is a committee of sorts. Janna suggested Pat talk to Dr. Peavey.
