Green Communities Update - Stephen

- Kathy: Kathy wrote to the .Bldg. Dept. about implementation of the Stretch Code. A return email said they thought stretch code never passed. Kathy contacted Steven who said he will look into it.
- There is still no date for next GC meeting which will probably occur in August. This meeting is in response to Steve's request to meet for project planning.
- The State has opened a fall opportunity for Stretch Code application.
- Concerning the Planning Dept, Jim LaCrosse said we should wait for the new planning director before involving this department.

Communication Update – Emily

Initial communications planned by this subcommittee will be to residents about MassSave and PV incentives.

This subcommittee proposes working with transportation and sustainability (now Complete Streets and GC) efforts to tell people about these efforts.

• Melissa and Tony thought this is good for consistency of branding and taking advantage of WEAC

members who know how to do outreach.

A possible lead on somebody to update the WEAC web site might not work out so we are still looking for someone to do this.

We will build up our facebook page (25 likes .. want more). Emily and possibly Stacy will work on this.

Priorities Meeting Update - Kathy

- Kathy reviewed meeting from yesterday (see minutes for the 11-jul-'12 WEAC meeting).
- Steampunk and Riverfest (May and June) were added as items on the yearly outlook as well as Stretch Code review in the Fall of '13.
- Tony suggested, if CG gets stalled (or as part of it) that WEAC could "adopt" a couple of buildings that are particularly energy wasteful and see what it takes to maximize improvement for them as examples of methods and benefits. WEAC could get the community involved.
 - Members agreed to look at this.
 - We decided to have Tony work up a white paper for next WEAC meeting and also present this to GCsubcom (part of the strategy discussion).
 - If we don't become GC then this can be independent program.
 - Maybe the library would be good.

Other business as required.

- Kathy will make list of tasks and distribute it. Then it will be included with minutes of this meeting as file "2012-m07-d12 ToDo.pdf."
- Hubway: Melissa: Even if inter city interconnects don't connect to a town, it can be its own node. Watham could be its own Node even though we don't connect back into Boston. Contract and ownership of equipment resides with the municipality (Waltham). Funding: \$100,000 for a station from the municipality and sponsors.

Melissa suggested this should be part of CS plan.

• Kathy: Climate Summer will be at Brandeis meeting tomorrow eve (7 to 9). Nobody, so far, is available to speak from WEAC.
