Councillor Randy LeBlanc moved to hear from Councillor Harris. The motion was approved on a voice vote. Councillor Harris supported the approval of the license. Councillor LeBlanc moved that the license be approved. The motion was approved on a voice vote and the matter was forwarded to the full Council with a recommendation for approval.

Lodging house renewal – 2 Appleton Street – Stan and Leni Bloomenthal

Councillor Logan said the conditions on these licenses regarding advertising had been in place for over 10 years and said that since this is supposed to be incidental to their business the holders for these licenses should not be marketing themselves as car dealers. Councillor Nabulime asked questions about the necessity of these restrictions. Councillor Romard said he

could not support removing the advertising restrictions. Councillor Romard asked to see the language side by side. Councillor Darcy said that the restrictions are counter to the license being issued and overly restrict the licences holders. Councillors Darcy and Logan reviewed the conditions. Councillor Darcy moved to table the matters collectively. The motion was approved on a voice vote.
