

Please be advised that the Waltham Police Department has been approved for the following grant award from the Executive Office of Public Safety and Security based on the federal funding to support this award from the National Highway Safety Administration:

➤ The FFY 2018 Child Passenger Safety (CPS) Equipment Grant Program has been awarded and requires no matching funds. This is for Two Thousand Six Hundred Twenty-five dollars (\$2,625.00).

The purpose of the Child Passenger Safety Equipment Grant is to purchase car seats and to assist those from our, and other communities, with car seat installation and education.

The Waltham Police Department has been committed to the child safety seat program for over 20 years. Through the years, even with budget constraints, we have never suspended this program. Our certified CPS Technicians are committed to the program and have worked diligently to reach out to Waltham residents who are in need of this service. Our fitting stations currently consist of 2 certified CPS Techs for 4 hours at least every 3 weeks.
