*Harrington Road Sidewalks*

Councillor Romard moved to take the matter from the table. The motion was approved on a voice vote. Councillor Romard moved to invite the City Engineer, the Mayor and Assistant City Solicitor Learned to the April 17, 2018 meeting of the City Council to discuss the calculation of betterments.
