MINUTES OF THE TRAFFIC COMMISSION MEETING HELD: JUNE 19, 2014 AT 10:00 A.M. HENRY HOOVER COMMITTEE ROOM, CITY HALL

The Chair motions to approve the minutes of the previous meeting. Voted

1. PETITIONED ITEMS:

A. Fourth of July – Parking Restrictions

Annual Fourth of July parking restrictions from Noon to Midnight. The previous annual restrictions were **voted approved.**

B. Lowell Street and Adams Street – Traffic Study

Councillor Rourke is requesting a traffic study be conducted with "complete street" principals among the proposed solutions. **Voted to have a in-house traffic study** that will include pedestrian, vehicular and bicycle safety measures for both Lowell Street and Adams Street. Any design work for construction purposes should be completed by an outside design firm.

C. Jimmy John's at 475 Winter Street – Traffic Impact Report

Ron Muller & Associates presented a Traffic Impact Study for this proposed gourmet sandwich restaurant. The proposal is a 40 seat, 1818 square foot gourmet sandwich restaurant which will reoccupy vacant space within the existing Reservoir Plaza. AM peak hour will approximately 80 trips weekday; 48 PM peak hour per weekday; and 99 vehicle trips during the Saturday peak hour. Presently the Plaza has 184 marked parking spaces and 30 vehicles park on the access road for a total 214 spaces. Peak hour Friday parking demand is 201 spaces. With this project the demand will rise to 215 spaces. The proponent has agreed to make modifications within the parking lot and restripe/redesign adding 6 spaces to make a total of 220 spaces available. Traffic Engineer, Mr. Garvin recommended the Traffic Impact Report submitted by Muller & Associates be forwarded to the City Council for their deliberations on issuing a Special Permit for this fast-food restaurant.

D. Everett Street – Traffic Calming measures

Councillor Marchese is requesting traffic calming improvements on Everett Street. It was voted to have Traffic Engineering proceed and review Everett Street for any traffic calming measures.

E. TD Bank Left Turn Restriction

McMahon Associates is requesting a "No Left Turn" restriction from the TD Bank site as requested by City Council. Traffic Engineer Mr. Garvin agreed that this restriction is needed. Voted to approve and post a "NO LEFT TURN" at the exit drive for 749-751 Main St.

Add to Schedule 18 TURNS ONLY AS DESIGNATED Main Street: All vehicle exiting #749-751 Main Street; Must Turn Right

F. Appleton Street – Reinstallation of "No Parking Except Sundays & Holiday" signs

Petition lacks required 65% signatures, but petitioner Theo Kinderman addressed the Commission and stated that the parking, on the west side is a benefit, was removed without any residential input. It was explained that more signatures would be needed for the Commission to entertain reinstallation of any parking. In addition, Appleton Street is 26 feet and in order to accommodate two-way traffic parking may only exist on one side of the street. **Voted to table for additional resident input.** (Note: Member Ms.Cagle excused herself, proximity to her residence)

G. Marivista Avenue at Trimount Avenue – All Way STOP INFORMATION ONLY Petition withdrawn due to lack of required 65% signatures.
