MINUTES OF THE TRAFFIC COMMISSION MEETING HELD: APRIL 16, 2015 AT 10:00 A.M. HENRY HOOVER COMMITTEE ROOM, CITY HALL

The Chair accepted a motion to accept the minutes of the previous meeting. **Voted to accept the minutes**

1. PETITIONED ITEMS:

A. Lowell Street – No Parking near Pine Street

Councilor Logan is requesting No Parking within 100' of the intersection on Lowell Street. Traffic Engineer Mr. Garvin reported a site review showed that there is no parking 30 feet from the corner, and a fire hydrant located 26 feet from the corner, then a driveway. A restriction of No Parking 36 feet from the corner is needed. This would prevent a vehicle from parking in the area of the fire hydrant and keep the corner clear for turning traffic. Councilor Logan who was present, agreed his request would be satisfied. Voted to amend No Parking as follows:

Add to Schedule 1 the following:

Lowell St., west side from Pine St. to a point 36' south of Pine St. No Parking.

B. Riverfest

Ms. Sarah Hankins with the Downtown Waltham Partnership, Inc. is requesting approval for parking spaces and closing of two easterly lanes on Moody Street Bridge. The event will be June 20th from 11:00 AM – 6:00 PM. Voted to approve the request for Saturday June 20, 2015 from 11:00 AM to 6:00 PM and close two northbound lanes of Moody Street from approximately #246 north over the Moody Street Bridge. One of the southbound lanes would be made northbound. In addition, parking spaces from #210 thru #246 (east side of moody St.) will be reserved for event vendors.

C. 275 Wyman Street – Special Permit Requirement Sign Offs

Attorney Robert Connors is required to have Traffic Commission sign off on certain Special Permit mitigation items. At the request of the City Council the following specific items relative to the Special for 275 Wyman Street were voted upon:

- 1: The petitioner is authorized to make changes to signal timing revise the signal timing at the following intersections to improve Levels of Service (a.) Winter St. @ 2nd Ave; (b.) Wyman St. @3rd Ave, (c.) Wyman St. @ Rt.128, d Smith St. @ Trapelo Rd., (e.) Wyman St. @ Lincoln/Smith. **Voted as requested**
- 2: The above signal timings to be at the satisfaction of the City's Traffic Engineer, Mr. Garvin. **Voted as requested**
- 3: Petitioner to install new traffic signal at intersection of Wyman/Smith/Lincoln replacing existing signal. **Voted as requested**
- 4: The above signal installation to be at the satisfaction of the City's Traffic Engineer, Mr. Garvin. **Voted as requested**

- 5: Install bicycle sharrows and corresponding signage on Wyman St

 Voted as requested
- 6: The petitioner is authorized to proceed with installation of the sharrows and corresponding sign

 Voted as requested
- 7: The petition is **not authorized** to synchronize (coordinate) the traffic signals at Trapelo Rd/ Smith Street and @ Wyman St./Lincoln/Smith Sts. due to intersections being over a quarter of mile away. Coordination will not provide the desired effect and they should operate independently **Voted as requested**
- 8: The petitioner is authorized to establish variable timing, based on time of day, at the traffic signals @ Trapelo Rd / Smith St and at Wyman/Smith/Lincoln Sts

 Voted as requested
- 9: The required established variable timing to be at the direction and satisfaction of the City's Traffic Engineer, Mr. Garvin **Voted as requested**
- 10: The petition is authorized to paint (in **THERMOPLASTIC)** "Do Not Block Intersection" pavement markings and corresponding signage, at the intersections of Smith/Loretta (both intersections); Smith/Snow Circle; Smith/Hersum Way; Smith/Wingate Rd. and Smith/Lincoln/Wyman St. **Voted as requested**
- 11. The petitioner is authorized to install speed limit signs on Lincoln Street between Wyman St./Lincoln St./Smith Street and Casey Circle. **Voted as requested**
- 12: Voted to delete from Schedule 18 (Turns Only As Designated)
 Lincoln Street all vehicles traveling westbound approaching Wyman St/Smith St
 In the left lane MUST TURN LEFT
- 13. Voted to add to Schedule 18 (Turns Only As Designated) the following Lincoln Street: all vehicles traveling westbound approaching Wyman/Smith St.in the right lane MUST TURN RIGHT Smith Street: all vehicles traveling in the southbound lane approaching Lincoln Street in the left lane MUST TURN LEFT

Each item, as requested was voted upon individually. All items were recommended by the Traffic Engineer to be approved or denied and were voted as indicated above.

D. 300 College Farm – Special Permit for Expansion

Conley Associates has submitted a traffic study for this project. Traffic Engineer, Mr. Garvin agreed with the conclusions submitted by Conley Associates. The addition of 3 units will not have an effect on traffic in this area. Voted to agree with the Traffic Impact Report and forwarded to the City Council for their deliberations on the issuance of a Special Permit.

E. National Brain Tumor Society "Boston Brain Tumor Ride"

They are seeking permission to hold this event on Sunday, May 17, 2015 at 8:00 AM. Lt. Cavallaro reported no streets will be blocked; 800 participants are anticipated and there will be police presence. **The Commission voted to recommend approval to the mayor for a Permit to issue.**

T.E. Mr. Garvin submitted a report on Long Term parking in City Lots. The report included costs for All time parking in 21 area communities. Mr. Magno expressed concerns relative to subsidized parking. Chief MacPherson had concerns for the Moody Street merchants who experience limited parking in the afternoon/evening diner hours. Mr. Kelly has thoughts of only \$2./day parking fee. Mr. Chiasson felt it may be a good idea the parking demands between Winter and Summer must be considered. With many questions to be answered it was voted to return the item to the table. **Voted to table.**
