# Waltham City Council Minutes of the Meeting of April 27, 2020

President Brasco called the meeting to order at 7:30 p.m.

#### Call of the Roll

The City Clerk recited the Council Prayer followed by President Brasco leading all present in the Pledge of Allegiance. Councillor LeBlanc asked for a moment of silence for all our military that have served past and present and for the first responders, medical professionals and all others assisting those with COVID-19 and for those who have lost their lives due to the virus. Vice President McMenimen asked for a moment of silence for former City Council President John Duffy who passed away on April 23, 2020.

President Brasco announced that the Council was meeting remotely and explained that residents could follow the meeting on the City's YouTube channel and on the WCAC MAC channels.

Councillor LeBlanc moved approval of the minutes of April 13, 2020. The motion was adopted on a voice vote and the minutes were approved.

### Public Employee Recognition Resolution

The Clerk read the Resolution. Councillor Harris spoke on the Resolution thanking all city employees for their dedicated service during the extraordinary times presented by the COVID-19 pandemic. Councillor Harris moved to suspend the rules to act on the Resolution without committee reference. The motion was adopted on a voice vote. Councillor Harris moved approval. A vote was taken by a call of the role.

### Management of COVID-19 in Waltham Resolution

The Clerk read the Resolution. Councillors Mackin stated that she has been asked two questions by constituents. First, what is Waltham doing to protect the homeless during these times? Second, what is going on with the big tents on the Common? Councillor Mackin indicated that she had two Requests. Councillor O'Brien stated that this is an important and timely Resolution to see what is being done to help Waltham's homeless. Councilor Paz indicated that he has received inquiries from constituents regarding the actions being taken by the City for the homeless during this crisis. Councillor Mackin's first Request was that the Mayor provide to the Council in writing a plan for accommodating people experiencing homelessness using the tents on the common or other resources, with information about a planned closure date and/or conditions that must be met before closure, what conditions would trigger a re-opening of the tent if closed, and a written policy for determining under what conditions the tent will remain open during the day for inclement weather or other circumstance, naming the person or authoritative body responsible for this decision. Councillor Mackin moved approval of the Request. The motion was adopted on a voice vote and the Request was approved. The second Request was that the Health Department provide the Council in writing a plan for providing testing for people experiencing homelessness, with information on how results will be communicated to the individual, what further services or referrals will be provided to people with a positive result and how the privacy of those tested will be ensured. Councillor Mackin moved approval of the Request. On the motion, Councillor Durkee asked whether the homeless are to be given priority over others who may need tests. Councillor Mackin indicated that the Request is not seeking a mandate but seeks information. Councillor LaCava asked whether Councillor Mackin had checked with the Health Department on a time frame for a response. Councillor Mackin indicated that she hadn't but that she hoped to have an answer in a week, although she had no firm time frame. The motion for approval was adopted on a voice vote and the Request was approved. President Brasco referred the Resolution to the Economic and Community Development Committee.

#### Open Space Resolution

The Clerk read the Resolution. Councillor Dunn spoke on the Resolution stating that the concept is something she brought up when the Council first learned of the proposed use of Jericho Hill. She stated that it appeared at that time that there is adequate acreage on the 554 Lexington Street site available for conservation and protection. Councillor Dunn indicated that she had a map including an overlay of the stone walls that she would provide to the Council. Councillor Vidal spoke on the

Resolution. He thanked Councillor Dunn for the opportunity to sign on the Resolution and stated that he looked forward to an open dialogue on the matter. President Brasco referred the Resolution to the Committee of the Whole.

### Arbor Day Resolution

The Clerk read the Resolution. Councillor LaCava spoke on the Resolution. He thanked the City's Tree Warden, Kevin Thompson, for his commitment to preserving trees and stated that a ceremony will take place at a future date. Councillor LaCava pointed out that the Resolution will help Waltham to maintain its designation as a Tree City. Councillor LaCava moved to suspend the rules to act on the Resolution without committee reference. The motion was adopted on a voice vote. Councillor LaCava moved approval of the Resolution. A vote was taken by a call of the roll.

Councillor Darcy further stated that it is the local option portion of the meals tax (0.75%) that he is proposing to temporarily remove. He stated that he wants Waltham restaurants to survive and prosper. President Brasco referred the Resolution to the Economic and Community Development Committee.
