The City desires to build a new Graverson Playground for the multitude of residents that live in the surrounding neighborhoods. Elsie Turner has served as the home for Waltham Girls' Softball for many years and is in need of modifications to make the field and areas safer and more functional for not only for Girls' Softball, but for residents who frequent the woods, open space and trails.
