Applicant: John Colbert—MWRA

Property Location: Linden Street ROW; Waverley Oaks Road ROW. Project is entirely in roadway

between approximately 182 Linden Street and 225 Waverley Oaks Road.

Project Description: Rehabilitation of existing water main (Weston Agueduct Supply Main –

WASM3).

Applicant has requested a continuance to 8/10/2023 to resolve tree hearing issues prior to finalizing the order of conditions.

Applicant: Chris Legocki – Greystar Development East, LLC.

Property Location: 379-395 Totten Pond Road

Project Description: The proposed project consists of razing the existing structures located on-site, and the construction of a five-story office/research laboratory building with attached structured parking and associated surface parking. Proposed work will occur within Inland Bank and the 100-foot buffer zone to Inland Bank and Bordering Vegetated Wetlands.

Applicant: City of Waltham Engineering Department

Property Location: 185 Lyman Street (Lyman Pond weir in Chester Brook) **Project Description:** The intent of this project is to modify and improve the weir structure located within Chester Brook.

Mr. Winn and Mr. Martino of the City Engineering Department present. ConCom is ready to issue conditions, but would like to confirm if DEP has technical comments. Mr. Winn reported that the DEP reviewer has not issued comments. Discussion focused on the administrative ramifications of approving the filing now or waiting to confirm with DEP. If DEP has major concerns, it could result in a superseding order of conditions and/or an appeal, which could lead to many months of delay. Mr. Winn plans to still proceed with some preliminaries, such as work discussion and estimates from contractors, so a short delay at this time will not be a problem while awaiting confirmation from DEP.
