 - Fill out all relevant information on the attached Food Truck Propane Storage Permit Application.
 - Complete the Food Truck Inspection Application.
 - CALL Fire Prevention 781-314-3710 to schedule your inspection.
 - Submit in Person at the time of your scheduled Inspection at the Fire Prevention Office, 175 Lexington Street, Waltham.
 Please park your truck behind the Fire Station near the Fire Prevention door. Come in and let us know you are ready.
 Bring BOTH applications and \$25 cash or check made payable to the City of Waltham.
