Requirements for a new Propane Permit:

- 1.) A completed Propane Install & Storage permit application.
- 2.) A site drawing of the property/tank location.
 - * Include measurements distance from building, windows, doors, street, property lines(s).)
- 3.) \$100 cash or check made payable to "City of Waltham". (\$50 for Install + \$50 for Storage)

*** Online payment is available. Go back to the list of permits, click on the words "PAID ONLINE".

Choose "Permit- Propane Installation & Storage" follow instructions to pay.

Print a copy of the payment to include with your documents.

### PROPANE PERMIT PROCEDURE - WALTHAM FIRE DEPT.

The following procedure for obtaining a permit for the installation of a propane tank and for propane storage in that tank shall be followed to provide compliance with 527 CMR 1.12.8.43.1

- (1) A representative from the company installing the propane tank shall apply in person at the Fire Prevention Office for the permit to install. A <u>site plan</u> shall be provided with the permit application showing the proposed location of the tank and the distance of the tank from property lines. A permit fee of \$100.00 must accompany the permit application. A permit to install will be issued to the company representative if all required information is provided and is approved by the Fire Department. \*\*This permit must be issued prior to the installation of any propane tank of 42 pounds (10 gallons) or more\*\*.
- (2) This form shall be completed by the company installing the propane tank and faxed to the Waltham Fire Prevention Office (781-647-0892) indicating that the propane tank for which a permit to install has been issued is ready for inspection. The inspection will be conducted by the Fire Department within a reasonable amount of time.
- (3) Upon satisfactory inspection of the tank installation by the Fire Department, this form will be faxed back to the firm which did the tank installation indicating that the installation inspection has passed and that a propane storage permit has been issued to the owner or occupant of the property (or failed with the reason(s) noted). \*\*Propane storage is not allowed prior to issuance of the storage permit\*\*

  Violation of this requirement shall be cause for immediate removal of the propane tank.

  Permits and satisfactory inspections for all piping and connections must be obtained from the City gas inspector prior to the use of any propane tank installation.

#### 527 CMR 1.12.8.43 Permits Required

1.12.8.43 Liquid Petroleum Gases and Liquefied Natural Gas.

1.12.8.43.1 Application for a Permit.

**1.12.8.43.1.1** An application for a permit shall be submitted by the person, firm or corporation who will make the installation or connection to an LP-gas storage container, in the name of the owner or occupant of the premises.

#### 1.12.8.43.1.2 Notice of Completion and Inspection of Work. 527 CMR: BOARD OF FIRE PREVENTION REGULATIONS

1.12.8.43.1.2.1 Upon receipt of notification of completion of the work, the AHJ shall make an inspection of the installation within a reasonable time. If same is found to be in accordance with Chapter 69 and if applicable 502 CMR 5.00: Permit Requirements and Annual Inspection of above Ground Storage Tanks or Containers of More than Ten Thousand Gallons' Capacity, the AHJ shall issue to the owner or occupant a permit for the keeping, storage, manufacture or sale of LP-gas in connection therewith, except where such storage is otherwise authorized by license.

#### 1.12.8.43.1.2.2 Violation.

1.12.8.43.1.2.2.1 If such installation is found not to be in accordance with Chapter 69, the permit shall be withheld and shall not be issued until the proper corrections have been made as directed, by written notice if requested, within a reasonably specified time and prior to any LP-gas being stored in the container(s).
