


1918 map

## Summary

A subdivision plan for the area on the east side of Willow Street near Navins Lane and Foundry Avenue was filed by William Corley in 1870. Thomas Hession, an Irish immigrant laborer at Waltham Bleachery and Dye, purchased lot #4 in the subdivision on Willow Street, corner of Navins Lane, in 1870. The deed did not mention any buildings. Hession lived at #1 River Street in 1871. When he sold the property to his son, Dennis, who then flipped it to Hannah Hession, the wife of Thomas, in 1873, the deed mentioned buildings on the lot. Therefore, the house at 164 Willow Street was very likely built in 1872-1873.

From 1870 – 2023, the property was owned by just two families and their descendants, the Hessions and the Delfinos. It was always an owner-occupied, single-family house. In 1936, Mary Kane, the daughter of Bridget (Hession) Kane and granddaughter of Thomas Hession, sold the house and land to Rose Delfino, the wife of Benjamin Delfino. Members of both families were ordinary working-class citizens who were employed at farming, local businesses, such as the Bleachery and Raytheon, or were self- employed.
