Robert Waters, City of Waltham Housing Department

Jeannette McCarthy, Mayor City Council put in various proposals to transfer care custody and control to the recreation department to expand the CHILL Zone, a program for the elementary kids in the city. In conjunction with Library, YMCA and Boys and Girls Club, we would like to expand this program for the kids at a high school level. We would like to add a chair lift to the back of the building. We proposed putting a handicap lift in the back, instead of the front of the building which is art deco style. In the rear of the building, there will be a lift with a platform. From a historic stand point the concern is the windows, we intend to replace the glass, and paint them the same color and in line with what is there now. Discussion with WHC and Presenters: You cannot see the lift from the street. It's a vertical platform lift, 750 lb capacity, made of steel and aluminum. The stairs will still be maintained for way of egress. The Mayor will send the specifications and the plans for the lift to the WHC. The Mayor will come back to the WHC in March, with plans and specs in detail, for the WHC to review.
