Comments by Applicant: Mr. Connors presented a set of plans showing the exact location of the house on School Street. There is a 6 family brick building that sits on the lot, separated by a fence, but the brick house is a part of the same lot. Board of survey has agreed to separate the one lot into two lots, using the fence as the separation line. The single family home will be demolished and a two family home will be put up in its place.

10. Old Business

a. 554 Lexington Street

Lorraine Finnegan- representing the City of Waltham

Commissioner Holmes would like to see Waltham preserve this house, and not tear it down. Move the house to a new location preferably in Waltham, where it can be re-used and appreciated. Not suggesting saving the addition of the house. Commissioner Russo wants to know locations in Waltham we could move the house too. Commissioner Holmes suggests to put a preservation easement on the home and sell it privately. Conduct a feasibility study to find out where this house could be moved too. Councilor Darcy is interested in viewing the house, and looking into a new site for the home to be re-located. Lorraine will reappear before the WHC at the June meeting with the information requested by the WHC.

- b. 125 Ash Street- Archie Bennett representing the owner of 125 Ash Street.

 Re-consideration on waiving the demolition delay determination. (4 months left on delay)

 A proposed structure was presented to the commission for new development. At the time of the determination, there was no plan for future development, now there is a proposed design. This house was the Methodist church rectory. WHC is suggesting bays on either side of the home, will add a more attractive, visual appeal to the neighborhood. Suggests showing more interest around the front entrances to make them look like a front entranceway, suggesting a presence of the neighborhood. (Porches, railings, columns etc.) New sketches and drawings will be sent to Pam, and the applicant will come back in June for a final decision to waive demolition.
- c. Modification to Historical Commission bylaws with regards to Section 106/Chapter 9 Commissioner Isaacson handed out a modification to the bylaws which clearly states the 30 day response period in which the state has to respond to the applicant. Ask the clerk's office if the city runs on calendar days or business days.
