4. Chair: Announcements: Commissioner Daly and Commissioner Isaacson went on a tour of 380 Lexington St house with a consultant, who was hired by the City of Waltham to inspect the home. As it turns out, we just received the report from the consultant today, which you the commission have not seen yet. We will add this to drop box. Please be sure to read this prior to the June meeting, as the project will come back before us at the June meeting. Chair: Reading and description of correspondence: Commissioner Isaacson did send the Mayor an email regarding the fence at the high school, and the request for a map of the area that fence will be placed.

5. Chair: Public hearings:

a. Demolition Delay Hearing: 78 Cherry Street Applicant Name: Arthur Bennett representing the owner, Stephen Douglas Comments by Applicant: Mr. Bennett read a brief report on his findings on the history of the home. The home is listed as a legal four family home however; the home now is non-conforming so the new structure will be an up to code three family home. Discussion by WHC: Commissioner Isaacson brought up the fact that if it's legally a four family, and the new structure will only be three, you are losing a unit, and potentially a home for a family. Commissioner Cox stated that vinyl siding can be removed, and is not permanent. Commissioner Cox asked questions pertaining to the design/architecture of the house, and the gables. Please note, no design plans were submitted to the commission. After stepping out of the room for a minute Mr. Bennett/Douglas would like a vote tonight on whether or not the house is historically significant. Applicant was advised that they could return in the future with a design for the replacement house and the decision would be reconsidered.

b. Demolition Delay Hearing: 25 Fiske Street

Applicant Name: Carl Attardo

Comments by Applicant: Mr. Attardo stated that he is not the owner of the house, and the owner is not listed on the application. He didn't think the owner needed to be listed on the application.

Discussion by WHC: The owner is not on the application; therefore we (WHC) cannot proceed forward with this public hearing. Pam will provide Mr. Attardo a copy of the WHC ordinance, which clearly states the owner must sign the application or provide a letter approving the appearance of the applicant. Pam will contact the building department as well to inform them as well. Mr. Attardo was invited to come back and attend the June public meeting if he submits a new application with the owner's signature, or letter from the owner approving the appearance of the applicant.

6. Development Prospectus hearings: 95 Moody Street

Applicant Name: Bret Francis on behalf of the owner Doreen O'Connor Comments by Applicant: 14 unit small apartment building with parking.

Discussion by WHC: Commissioner Isaacson presented some history on the building that had once stood on that lot and its historic nature. Commissioner Isaacson would like to know if a plaque could be put up as a historical reference for the workshop of Weathervane Manufacturing Leonard Cushing, that once stood on that property. Commissioner Cox has stated that the location is very significant, and very important, being so close to the Boston Manufacturing mill, a gateway to Moody Street, Grover Cronin's, and the Waltham Common, so it's in an area of tremendous historical significance for the city. The design of the building is very important.
