Discussion by WHC: Commissioner Daly read a brief report of her findings on the history of the property. In 2015, the garage on the property came before the commission, which was declared unfit by the city, so we (WHC) approved the demolition of the garage. Architecturally it has significance and is a part of the street scape. This home meets two of the criteria, the age and the architecture context.

a. Discussion of 380 Lexington Street

Summary: Steve Cazassa, Eric Carlson, Joe Pedulla and Mike Garvin We are here asking for your determination of the historical significance of the house on 380 Lexington St and consideration on your disposition of the report submitted on May 7, 2018.

Discussion by WHC: Commissioner Isaacson does not feel like the report provided any new information that wasn't already known. The question that we need to determine is given the house in its current condition and given the current situation with the intersection, is the house historic enough to warrant us trying to preserve it somehow. The house is in conflict with the current traffic plan says Steve Casazza. If we were to preserve the house and have it shifted on the lot, would that change the design of the intersection, asked by Commissioner Isaacson? Michael Garvin, City Traffic Engineer, in order to get the necessary traffic and safety improvements the house can't remain where it is today. The historic report laid out the three options for the city, the house remains where it is, the house is moved on the property, or the house is demolished. There is a corner of the property the house could be moved to get the proper alignment of the road. Whether the house is moved or is demolished, the road alignment would be the same. Commissioner Daly believes the consultant's report does not answer our question of "can the house be moved?" Joe Pedulla addressed the report, stating the consultant did not comment on that aspect, since it was not their expertise. Commissioner Isaacson met with a professional house moving company today at the house, to discuss the possibility of moving it. Practically speaking, you could move the house with the chimney with no problems, however to move the house and pour a new foundation would cost a few hundred thousand dollars, and in the mover's professional opinion, the house was not worth moving based on its current condition.

Commissioner Cox spoke about what on the exterior façade that detracts from its original historic nature? The windows, siding, the doors, stone steps that we not there before, however, the house could be restored. Selling the house and saving the money on the demolition is something to consider too.

Commissioner Holmes spoke about her reasons for requesting a historic architect and a report, along with discussing the historic criteria of the house. Commissioner Holmes believes the house does not meet the 7 criteria any longer, the significance has been compromised.

Commissioner Daly would like to know if the house were to be demolished would there be a small area of open space? If so, name that area after the Abner Sanderson family to commemorate them.

Commissioner Russo would like proper documentation on the preservation of the house if it's demolished, and have that information available for other's who are interested in historic home preservation and renovation.

Commissioner Wilson is in favor of keeping the house and moving the house on the property.

Steve Casazza stated the city is asking if the house is historically significant and does it need to be preserved? Commissioner Isaacson: this is not a demolition delay hearing, therefore, Commissioner Holmes confirmed the commission will comment on whether or not the house still retains historical significance and can it be moved.

Motion that the historical commission recommend that the city not spend the effort and money to move this house on the lot because the house has lost its historical significance made by *Commissioner Daly*
