10. Old Business: Arrigo Farm

Jon Millian- Director of Building Maintenance

Seeking a letter of support for the CPC, in the amount of \$1.3 milion dollars for the rehabilitation work to Arrigo Farm. Much of this had been discussed at the previous meeting.

It was again emphasized that this is one of the oldest farms in New England, c. 1635; that the family made significant contributions to New England, Waltham, and Watertown; and that the last member of the original family to die in the house in 1922 descended from both the Mayflower and the Arbella. No internal work will be done, except structural work as needed. The commission requested that good documentation of the structure before work begins should be done, and that important structural elements, such as framing joints, that must be replaced should be salvaged. Both of these considerations were agreed to by the applicant.
