

LICENSING BOARD FOR THE CITY OF WALTHAM

RULES AND REGULATION

ALCOHOLIC BEVERAGES NOT DRUNK ON THE PREMISES

- 1. No license can be sold, transferred or surrendered without authority of the Board.**
- 2. No license shall be issued to any person who is not a citizen.**
- 3. All licenses must be posted on the premises specified so that they may be easily observed.**
- 4. Records of all liquors and beverages sold must be kept available when called for by members of the Board, or their Agents. The licensing Board or their Agents may at any time enter the premises of a person who is licensed by them, to ascertain the manner in which such licensee conducts his business.**
- 5. Sales TO or BY persons under twenty-one are punishable by fine or by imprisonment or both.**
- 6. The hours for the sale of liquor are as follows:**

Weekdays except holidays	8:00AM to 11:00PM
Legal holidays, except Christmas, Thanksgiving and Memorial Day	12:00 Noon to 11:00PM
Christmas, Thanksgiving and Memorial Day	Closed all day

May remain open until 11:30 PM on any business day which immediately precedes a holiday.

- 7. Each corporation license must appoint a manager by a properly authorized and executed written delegation with full authority and control of the premises and who must be satisfactory to the Board. Immediate notice of the appointment must be made to the board in writing.**
- 8. No person shall keep for sale or sell in any part of the premises not specified on the license.**
- 9. No alcoholic beverages shall be sold to a person who is known to be a drunkard, to an intoxicated person, or to a person who is known to have been intoxicated within the six months last preceding, or to a person known to be supported in whole or in part by public charity.**
- 10. No alcoholic beverages shall be given away.**
- 11. A price list of the liquors to be sold shall be kept conspicuously posted. All sales of alcoholic beverages shall be made at the prices stated on the current posted price list. No price list of liquors shall be displayed in the windows or in any other place where visible from outside the licensed premises.**
- 12. All liquors shall be sold only in the original manufacturers' or wholesalers' and importers' packages.**

- 13. Revised Licensees may sell on Sundays from 12:00 Noon to 8:00 PM.**
- 14. Registered Pharmacists and licensees under Section 30-A, of the Liquor Control Act, shall make no sales of alcoholic beverages or alcohol on any holiday, except upon a physician's prescription.**
- 15. No delivery of alcoholic beverages unless vehicle is registered with Alcoholic Beverage Control Commission of the Commonwealth of Massachusetts.**
- 16. It is the responsibility of the licensee or designee to contact the police IMMEDIATELY if a problem arises in their establishment.**

IMPORTANT: ALL LICENSES, PERMITS, TAX STAMPS AND THESE RULES AND REGULATIONS SHALL BE DISPLAYED ON THE PREMISES COVERED BY THE LICENSE OR PERMIT IN A WELL LIGHTED AREA, NEAR ENTRANCE WHERE THEY CAN BE EASILY READ BY ALL PATRONS AND EMPLOYEES.

THE LICENSE IS SUBJECT TO SUSPENSION OR REVOCATION FOR BREACH OF ANY OF ITS CONDITIONS OR ANY LAW OF THE COMMONWEALTH.
