1. Conservation Restriction – 0 Chesterbrook Road. AKA 605R Lexington Street

Councillor Darcy asked the following questions;

Where is the funding needed to implement these Conservation Restrictions. The Mayor said funding is not part of this request. These need to go out to bid first.

Section 11 A.6 Trail bikes are listed as prohibited from using the conservation area yet bicycling is allowed in 11,B.10. The Mayor said the Law Department should remove bikes from #10.

Section 11.B.6 The proposed CR states that paths shall be made only of dirt. ADA requirements are stone dust for wheelchairs.

Section 111.A.1 Is it the intent to make the grantee seek authorization from the Waltham Conservation Commission for ay work or just within the wetland area ?

Sections 111A.2 Ability to place discrete signage for tree inventory and vegetation.

Councillor Darcy moved to table the matter. Motion was adopted on a voice vote.
