Whereas: the purchase of this small parcel would secure yet another small piece of land added to the park, and allow for increased public access to Prospect Hill Park and its near-by trails and hiking paths, therefore



Based on the offer of \$88,000 to acquire the land located at 334R Prospect Hill Road, having a Parcel ID. of R040-001-0021, consisting of 77,696 sq. ft. or 1.8 acres of land, I have reviewed my data and find that the offer price reflects reasonable value for the property.
