The Waltham City Council will meet in the Council Chamber at City Hall, 610 Main Street, Waltham MA on Monday, November 27, 2017 at 7:30 pm. The following matters and others may be considered.

#### **Approval of Minutes**

#### **Communications from the Mayor**

1. The Mayor respectfully requests that the care, custody and control of the land and building known as 655 Lexington Street be transferred to the Waltham School Department. As you know, the School Department is a direct abutter to this property, and best able to address the parking limitations of this former teen center site.
2. The Mayor respectfully requests that the care, custody and control of the land and building known as Fitch School, 14 Ash Street, Waltham be transferred to the Waltham School Department.
3. The Mayor respectfully recommends and requests support to demolish the Metropolitan State Administration Building through the appropriate processes.
4. The Mayor respectfully asks that the appropriation request for the Police Station and that the City Council enact zoning to allow occupancy of the police at Fernald. The renovation of the Police Headquarters is the Police Chief's priority. On April 22, 2013, the City Council agreed to \$506,000.00 for the design of the Police Station Headquarters on Lexington Street (copy enclosed). After designed, I sent it out to bid. The bid was awarded subject to appropriation. My appropriation request has been tabled by the City Council. If CPW and Engineering move from the first floor of the 911 Building, that space is potentially available for the Police Department. Additionally, there is always room for expansion at the Muni Center site if the police/fire need it. I have asked for temporary occupancy of Marquadt at Fernald for the police and I have asked for permanent occupancy for Veterans' Housing.
5. The Mayor respectfully requests the re-appointment of Paul L. Maillet of 160 Hardy Pond Road, Waltham, MA as a Constable.
6. The Mayor respectfully submits her recommendations for the Master Plan for Fernald Property (190 acres).
7. The Mayor respectfully requests approval of an additional donation of \$10,000.00 from the Last Call Foundation to the Fire Department to purchase rescue airbags. An initial donation of \$10,000.00 was approved by the City Council (Order #33861) at its meeting of October 23, 2017.
8. The Mayor respectfully requests an appropriation of funds in the amount of \$150,000.00 to engage a designer for improvements to the Cornelia Warren Playground. The funds will be used for improvements to the facility, including the softball field, parking areas and to explore other recreational amenities.

9. The Mayor respectfully requests approval of the attached loan authorization in the amount of \$1,600,000.00. The funds will be used to provide for the design and construction of the improvements to Prospect Hill Park.

10. The Mayor respectfully requests an appropriation totaling \$26,500 for the Disability Services Commission to fund numerous handicap projects. These items were voted and approved by the Disability Services Commission. The Chairman of the Disability Services Commission will be available to answer questions concerning these requests.

11. The Mayor respectfully requests an appropriation of funds in the amount of \$19,800.00 to perform engineering services for a hydraulic analysis and prepare a hydraulic report for the potential flood storage upstream of the Trapelo Road culvert over the Beaver Brook. The study was requested by the Department of Conservation and Recreation (DCR) to evaluate flood mitigation measures for the culvert replacement project at the Trapelo Road location.

12. The Mayor respectfully requests an appropriation of funds in the total amount of \$975,000.00 to apply towards the award of the low and responsible bid for HVAC improvements at the Waltham Community and Cultural Center (WCCC).
