Fuel Storage

In accordance to Chapter 148 of the Massachusetts General Laws and Chapter 8 of the General Ordinances of the City of Waltham, ARE-MA Regional No. 63, LLC, with an address of 400 Technology Square, Suite 101, Cambridge, MA 02139, as Petitioner and Owner of 275 Second Avenue, hereby petitions the City Council for a fuel storage license for an existing 539 car parking garage, to locate a new diesel generator with 196 gallons of storage within the garage, and to store up to 1,000 gallons of flammable and combustible liquids within the existing building for laboratory research use.
