Dear Councillors:

On April 20, 2017, I asked 4 questions regarding land necessary for traffic improvements above.

On August 25, 2017, I sent notices to 8 property owners (sample attached):

1362 Main Street	132	SF	1352 Main Street	230	SF
1273 Main Street	2,215	SF	1344 Main Street	360	SF
	30	SF	75 Third Avenue	1,040	SF
1335 Main Street	1,170	SF	1290 Main Street	70	SF

Two have responded, 75 Third Avenue and 1290 Main Street. After my meeting with the agent for 75 Third Avenue and the property owner, I received the September 22, 2017 letter attached. I have no substantive update on that, other than they met with the traffic engineers to discuss their concerns, and were going to get back to me.

The owner of 1290 Main Street has made the attached proposal to the City.

I will be getting prices for appraisals for 7 of the 8 parcels.

I respectfully ask the following:

- 1. To accept the 1290 Main Street offer, and proceed with the necessary paperwork;
- 2. Prior to expending any City money, what, if anything, is my authority on these ROW acquisitions?

Dear Mr. Pagliazzo:

Historically, the State Department of Transportation (DOT) requires local communities to be responsible for any Rights of Way (ROW) acquisitions for traffic, bridge, road, and sidewalk improvements.

In relationship to two traffic improvements: a new Rt. 117/Main Street Bridge and traffic signals for Third Avenue (allowing traffic to proceed to Totten Pond Road without having vehicles go down to Wyman Street and then back up to Totten Pond Road), there are 8 potential acquisitions:

We look forward to working with you and the City of Waltham in connection with these matters.


