

Request for Transfer - Additional Funding for Fuel Efficient Hybrid Vehicle

Recently, we received a funding transfer appropriation in the amount of \$18,060.85 to purchase a Ford Fusion for the Water Meter Reading Crew. However, we have since been advised that the City of Waltham has adopted a new Green Fuel Efficiency policy; for two-wheel drive passenger vehicles, the miles per gallon requirement must be at least 29 MPG; this Fusion model only gets 25.95 MPG, and therefore does not meet the new standards.

We have obtained a quote for a Ford Fusion SEL Hybrid Sedan, which fully complies with the new fuel standards with a combined MPG of 42. However, the price is higher than the original. We respectfully request an additional \$6,844.15, which will provide us with enough money to purchase this vehicle. The quote attached from MHQ, reflects MA State Contract Pricing through the Greater Boston Police Council.
