Second agenda item: Minor Modification for Uma Flowers at 196 Bear Hill Road Attorney Valero Romano of Elm Street in Cohasset, representing the petitioner spoke on the minor modification. They are not going to build out the foyer. This is approximately234 sq. feet and all changes are related to the interior of building. Utilities that were to be required are now not needed. Councillor McLaughlin asked if it affects the security of the building. It does not. Councillors LeBlanc, O'Brien and Dunn all asked questions. Attorney Connors drafted a proposed decision and added the 2 conditions; sidewalk to be clear and signage to conform to the ordinance. He will submit a time extension as well. Councillor Dunn asked about snow storage. Councillor McLaughlin and LeBlanc reiterated the landlord has done a great job in the past with clearing snow from this property. Councillor McLaughlin moved to table the matter. The motion was approved by a voice vote.
