#### Christopher Road Water Main

Councillor Brasco moved to take the matter from the table. The motion was approved on a voice vote. Councillor Fowler moves to hear from an off committee members City Engineer Stephen Casazza and Councillor George Darcy. The motion was approved on a voice vote. Councillor Darcy asked Mr. Casazaza to explain the work. President LeBlanc, Councillor Romard and Coucnillor Darcy asked questions about the scope of the work. Mr. Casazza identified the work being proposed and how the repairs have been prioritized by the Mayor. Councillor Romard moved to lay the matter on the table. The motion was approved.
