The Waltham City Council will meet in the Council Chamber at City Hall, 610 Main Street, Waltham MA on Monday, September 11 2017 at 7:30 pm. The following matters and others may be considered.

Joint Public Hearing
Zoning Ordinance Amendment

Brandeis University, 415 South Street, Waltham, Massachusetts 02453 and Cellco Partnership d/b/a Verizon Wireless, 118 Flanders Road, Third Floor, Westborough, Massachusetts 01581 hereby petitions the City Council and the Board of Survey and Planning of the City of Waltham Massachusetts to amend Part III (formerly Chapter 21) of the General Ordinances of the City Waltham entitled "Zoning Code" as follows:

1. ARTICLE X entitled "Wireless Communications Equipment," Section 10.52 entitled "Roof- or top-mounted wireless communication equipment" is hereby amended by adding a new paragraph "(c) Notwithstanding the foregoing, Roof- or top-mounted wireless communication equipment is allowed in all zoning districts if entirely located within the property of a public or private educational university institution which is fully accredited by recognized private, state or federal organization by special permit of the City Council in accordance with Section 3.5."
2. ARTICLE X entitled "Wireless Communications Equipment," Section 10.53 entitled "Façade-mounted wireless communication equipment" is hereby amended by adding a new paragraph "(c) Notwithstanding the foregoing, Façade-mounted wireless communication equipment is allowed in all zoning districts if entirely located within the property of a public or private educational university institution which is fully accredited by recognized private, state or federal organization by special permit of the City Council in accordance with Section 3.5."

WHEREFORE, the petitioner prays that, after due notice and hearing as provided by law, the City Council may by Order grant to the petitioner permission to construct, and a location for, such a line of conduits and manholes with the necessary wires and cables therein, said conduits and manholes to be located substantially as shown on the plan made by A. Debenedicitis, Dated August 2, 2017 and filed herewith, under the following public way or ways of said City: South Street - Easterly from pole 23/87 approximately 227 feet south of Charles River Road a distance of 49 ± feet of conduit

1. The Mayor respectfully requests a bond appropriation for the purchase of the fee interest in the Stigmatine land.
2. The Mayor respectfully submits the bid response for Air Rights above a Portion of the Parking Lot Located at 230-234 Moody Street and would like to know the Council's recommendation.
3. The Mayor respectfully submits the 101R Elm Street Draft Phase 1 Report with the request for Council's recommendation.
4. The Mayor respectfully requests acceptance of a gift of 3 New England grown Redbud trees from the Waltham Land Trust to honor the memory of one of their founders, Joris Naiman. These trees will be planted on the Waltham Common with a small plaque.
5. The Mayor respectfully requests an appropriation in the total amount of \$48,100.00 from the Library State Aid account to the Library Educational Supplies, Training, Out of State Travel and carpeting accounts.
6. The Mayor respectfully requests a transfer of \$5,000.00 to fund the civil service exams for the E911 Dispatcher exam and the Clerical exam. This funding request will be offset by the application fee for the exam paid by each applicant.
7. The Mayor respectfully requests a transfer of funds totaling \$25,850.00 (as itemized below) to fund the second year (FY2018) of the three year collective bargaining agreement between the City and the School Traffic Supervisors' Union for the period July 1, 2016 to June 30, 2019. The funding for the first year (FY2017) of the agreement in the amount of \$13,010.00 will be provided from excess funds in the FY2017 Police budget.
8. The Mayor respectfully requests acceptance of a grant of \$10,843.00 from the Edward Byrne Memorial Justice Assistance Grant to the City of Waltham Police Department. This grant will be used to create a citizen survey to gain knowledge of how Waltham residents perceive crime, disorder, police and other issues. It will also be used to increase officer foot patrols in the downtown area. No match is required for this grant.
9. The Mayor respectfully requests a transfer of capital improvement funds in the amount of \$38,527.00. These funds will be used for the design services of the sewer main rehab project on Woerd Avenue.
10. The Mayor respectfully requests to have a road dedication ceremony in September.
