Memorandum of Understanding of Settlement of All Claims
Rights & Damages

The parties to both above-listed pending cases agree to settle any and all claims involved in said cases, and any and all other claims either has against the other, on the following terms, in full & complete settlement release & waiver of any & all actual or potential past current or future claims of the parties.

The City of Waltham shall pay The Stigmatis Fathers \$30,000,000 for the fair market value of the property taken. This shall include the \$18,000,000 previously paid. Further, subtracted from the amount due shall be \$1,000,000 which the Stigmatis are reimbursing the City as compensation for environmental clean up / remediation.

Therefore, new money due to The Stigmatis Fathers is \$11,000,000. Resulting in total of payments to the Stigmatis Fathers of \$29,000,000 in full & complete settlement of any & all claims*. Said amount shall be paid on or before ~~February 6, 2020~~^{March}, or else interest on said amount shall accrue at 7.5% per annum.

This settlement is subject solely to approval of Waltham City Council for the additional \$1,000,000 appropriation and bonding thereof.

Dominibus Full mutual release of all claims to be drafted and shall include mutual non-disparagement agreement damages of any type, whether under state, federal or common law.
