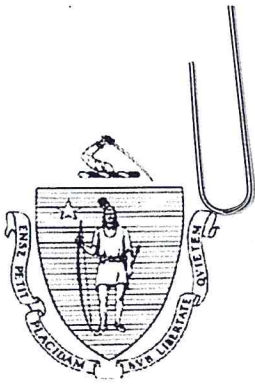
Mayor,
