Council President Marchese called the joint meeting with the Board of Survey and Planning to order at 7:30PM.

City Clerk Rosario Malone clerked the meeting.
President Marchese made announcements. He acknowledged The Emberley's celebrating their $60^{\text {th }}$ wedding anniversary. Mrs. Karamanica is celebrating a $95^{\text {th }}$ birthday. Maria Sheehan received the Chamber of Commerce Award, Jeff Stanton was voted the President of the Waltham Chamber of Commerce and he congratulated School Committee member Teddy Tarallo and his wife on their new baby girl.

Seasonal Outdoor Seating
CHAPTER 21 of the General Ordinances of the City of Waltham entitled "Zoning," as most recently amended, is hereby further amended as follows:

ARTICLE V entitled "Parking Requirements," Section 5.23 entitled "Parking requirements for the Business C District" is hereby amended by adding the following new subsection:
5.234 Seasonal outdoor seating shall not be included in the calculation of the parking requirement in the Business C Zoning district provided that there are less than fifty (50) outdoor seats, seating and tables are not permanently fixed in place, and that seating and tables are removed between the last day of October and the first day of April.

Councillor Robert Logan spoke in favor of the petition.
With no one else in support and no one else in opposition and no one in a neutral position on the petition, President Marchese closed this portion of the public hearing and opened the hearing to questions from Councillors and board members.
Mr. Barrett of the Survey and Planning Board ask if you would need a permit to have seating. Councillor Logan stated not unless it was on city property.
There were no further questions from Councillors or Board Members. President Marchese closed the public hearing and referred the matter to the Ordinances and Rules Committee.

## The Clerk read the second public hearing.

 ZOA Pub/BreweryCHAPTER 21 of the General Ordinances of the City of Waltham entitled "Zoning," as most recently amended, is hereby further amended as follows:

ARTICLE III entitled "Establishment of Districts," Section 3.2 entitled "Definition of uses," Subsection 3.228A entitled "Micro-Brewery Restaurants" is hereby amended by striking in the first sentence the following:
"farmer's brewers statutes"
and inserting in place thereof the following:
"pub brewery license statute (M.G.L. Chapter 138, Section 19D)"
ARTICLE III entitled "Establishment of Districts," Section 3.4 entitled "Table of Uses," is hereby amended by deleting under the category "Commercial," for the use entitled "Microbrewery restaurant," in the columns for the Business C (BC) and Limited Commercial (LC) Zoning Districts the following designation:
"S1"
