## FINANCE COMMITTEE

(Meeting re-convened from June 8, 2015) Minutes of the Meeting June 15, 2015

- 1. Chairman Brasco re-convened the meeting of June 8, 2015 at 5:00 pm to continue the review of the FY2016 budget.
- 2. Chairman Brasco requested that attendance be taken by a roll call. The Clerk called the roll Councillors Giordano, McMenimen, Vizard and Chairman Brasco were in attendance. Councillor Romard was absent.
- 3. Councillor Giordano moved to re-authorize the revolving account for the City Clerk for FY2016. The motion was adopted on a roll call vote (attached) of 4 in favor, 1 absent.
- 4. Councillor Giordano moved to re-authorize the revolving account for the Council on Aging for FY2016. The motion was adopted on a roll call vote (attached) of 4 in favor, 1 absent.
- 5. Councillor Giordano moved to re-authorize the revolving account for the recreation Department for FY2016. The motion was adopted on a roll call vote (attached) of 4 in favor, 1 absent.
- 6. Councillor Giordano moved to approve the FY2016 Parking Meter budget in the amount of \$334,421. The motion was adopted on a roll call vote (attached) of 4 in favor, 1 absent.
- 7. Councillor Giordano moved to approve the FY2016 School Department budget in the amount of 77,181,798. On the motion, Councillor Vizard disclosed that his spouse was a teacher and he had received a ruling, filed with the City Clerk, from State Ethics Commission that he was able to vote on the School Department budget. Councillor McMenimen stated she would vote for the School Department budget, but with great reluctance. Councillor McMenimen commented at length of the additional costs attributable to and needed to support the School budget that are in the municipal budget healthcare, pensions, debt service, etc. Councillor McMenimen quantified these indirect costs to demonstrate the true dollar amount of the School budget and that it represents 53% of the total General Fund budget. Chairman Brasco stated he would not support the amount of the School department budget, questioning the

salaries of the top level administrative positions and the amount of surplus funds that may be returned at the end of FY2015. The motion by Councillor Giordano to approve the FY2016 School Department in the amount of \$77,181,798 was adopted on a roll call vote (attached) of 3 in favor (Giordano, McMenimen, Vizard), 1 opposed (Brasco) and 1 absent (Romard).

- 8. Councillor Giordano moved to approve the FY2016 City budget in the amount of \$160,315,463. On the motion, Chairman Brasco moved to cut the newly created position of Park Ranger in the Recreation Department in the amount of \$60,903. The motion did not carry on a roll vote (attached) of 2 in favor (Brasco, Giordano), 2 opposed (McMenimen, Vizard) and 1 absent (Romard). Chairman Brasco moved to cut the newly created position of Facilities Supervisor I in the Recreation Department in the amount of \$42,575. The motion was adopted on a roll call vote (attached) of 3 in favor (Giordano, Vizard, Brasco), 1 opposed (McMenimen) and 1 absent (Romard). The motion to approve the FY2016 City budget (as amended) in the amount of \$160,272,888 was adopted on a roll call vote (attached) of 3 in favor (Giordano, McMenimen, Vizard), 1 opposed (Brasco) and 1 absent (Romard).
- 9. A motion to recess the Finance Committee until the next Finance Committee meeting of June 15, 2015 was adopted on a voice vote 6:30 pm.
