There is a concern about lead in the paint; Ann will reach out to the purchasing department and also research about the lead paint. Programs were talked about

including field trips to the house. Major Announcement, the Waltham public library and Stonehurst are working together and offering books up at Stonehurst to read in house or take home. Edu. & Outreach: House plaques were discussed; waiting on the response from Wayne McCarthy. House brochures were approved on the content at the outreach meeting. Macris Listing and National Register of historic places were discussed. Working to get the Tracy Jackson house updated in Macris and listed on the National Register. Stonewall Subcommittee: Working on putting together the CPA application, put an estimate email out for the work that will need to be done. We have received one response back on a quote estimate. Mort spoke briefly about the old stonewalls that sit on the squad rant lines by the high school. Richardson asked the committee about who should draft the ordinance? They suggested that we the WHC do that. A rough draft will be presented to the commission in April.
