Representing the project: Mayor McCarthy, Housing Department, Architect Alex Knox The mayor is asking for review and input from the Waltham Historical Commission in regards to the exterior of the building. All 3 buildings were surveyed and Cardinal Cottage was put forth to be restored.

Alex Knox: Presented documents to the commission on the exterior of the cottage and is seeking approval after the documents and photographs are looked over for the outside of the building.

The outside work was discussed by Alex Knox.

Alex Knox presented photographs of the exterior of the building and what he is suggesting the Cardinal cottage would look like, color would be gray with white trim, and possible red incorporated throughout. The first floor level will be handicap accessible with a ramp in an inconspicuous corner of the house. Photographs of the siding were presented.

Discussion by the WHC: Cox asked about the main door, and the answer is to restore the door and put back in place on the original hinges. The windows currently are two by two, and Commissioner Holmes thinks the two over two would be original to the Greek revival style of the home.

Mayor- There are surveys on each of the buildings. The commission will get a copy of the surveys. Alex Knox went before Mass Historical and local Historical to comply with local and state regulations. There is a proposed use of the interior to city council, but no word yet. If the commission has any comments regarding the design they should email them to Alex Knox. No vote was taken for the Cottage at this time.
