As part of our effort to deliver reliable energy to our customers and communities, Eversource will soon be conducting maintenance work in its right of way (power line corridor) in Waltham and Lexington. This maintenance work includes replacing wooden transmission structures with steel structures. Maintaining the infrastructure that supports electric lines is one of the many ways Eversource ensures the safe, secure transmission of electricity throughout the region. As we perform this necessary work, we are continuing to follow COVID-19 health and safety guidelines.

We Are Always Working to Serve You Better

Starting soon, Eversource and its contractors will begin work replacing transmission structures on or near your property.

What You Can Expect

Since your property is on or near the project route, here is important information about how we will work in your neighborhood:

- Reliable Service: Be assured that this work will not interrupt electric service to your property.
- **Proper Identification:** All people working on this project carry identification.
- Where We Will Be Working: Construction activity will take place within the existing right of way (powerline corridor) near the following cross streets:
 - Waltham: Smith Street, Trapelo Road, Loretta Road, Silver Hill Lane, Wyman Street, Winter Street, 5th Avenue, Silver Hill Lane, Tracer Lane, Lincoln Street, Totten Pond Road
 - Lexington: Candlewood Drive, Crestview Road, Midland Drive, Priscilla Lane, Lincoln Street, Marrett Road
- Communication: Keeping the lines of communication open is important to us. <u>Please contact your Project Outreach Coordinator</u>, Logan Trupiano, at 781-552-2979 to discuss any issues and to provide your contact information so he can keep you updated on progress.
- Construction Hours: The hours for construction are 7:00 a.m. to 7:00 p.m. Monday through Saturday.
- Construction Activities: Project construction will occur in phases, including the following:
 - Crews conducting survey digging in certain areas prior to construction activities.
 - Construction vehicles on the right of way, including heavy equipment, though we will make every effort to minimize any impact to your property.
 - Site grading, mowing/vegetation removal, adding gravel to the access road, and setting timber mats in wetland areas.
 - The wood structures will be replaced with steel structures of similar height.
 - When the project is completed, crews will restore areas that were disturbed by the work.
- **Project Completion:** We expect the work for this project to be complete by the Winter of 2022.
