This RFQ is the first phase of a two-phase procurement process as set forth in MGL Chapter 149A. The SBC through its Prequalification Committee will prequalify firms interested in providing public Trade Contractor services on this Public Construction Manager at Risk ("CM at Risk") Project. The required SOQ is different from DCAMM Certification. All Trade Contractors must be prequalified for this project, even if the firm is DCAMM Certified. Based on the SOQs received, the Prequalification Committee will prequalify respondents it deems to be qualified in accordance with the criteria set forth in the RFQ. Only prequalified firms will be permitted to submit bids for the category of work in which they were prequalified.
