

# **Executive Summary**

### AP-05 Executive Summary - 91.200(c), 91.220(b)

#### 1. Introduction

In accordance with Title 24 Code of Federal Regulations (24 CFR) Part 91, the City of Waltham is required by the U.S. Department of Housing and Urban Development (HUD) to submit an Annual Action Plan (AAP) no less than forty-five days from the start of the community's new program year (PY). The City of Waltham publishes this document as the AAP for PY49 which begins July 1, 2023 and runs through June 30, 2024.

The City of Waltham's PY49 AAP describes the anticipated uses of Community Development Block Grant (CDBG) funds received as a series of initiatives to be accomplished by the City for the duration of the program year. This period is simultaneously the fourth year in a five-year strategy captured in the *FY2020-2025 Consolidated Plan*.

#### 2. Summarize the objectives and outcomes identified in the Plan

The City of Waltham has adopted four goals for community development within its FY2020-2025 Consolidated Plan. To achieve progress in meeting these goals, the PY49 AAP proposes to allocate PY49 CDBG funding through four goal-aligned categories:

- Housing Rehabilitation: \$57,000 or 6.7% of CDBG funding to undertake activities related to code compliance, energy efficiency, handicapped accessibility, weatherization, and emergency repair for owner and renter-occupied housing units through zero interest deferred loans to property owners. This also includes administration costs for Housing Division staff.
- <u>Public Facilities/Improvements: \$493,174</u> or 58.3% of CDBG funding to repay a portion of Section 108 loan principal awarded, and towards creating accessible and sustainable improvements.
- <u>Public Services: \$126,962</u> or 15% of CDBG funding to provide grants to social service organization sub-grantees that provide services to underserved populations and to accomplish public service activities.
- <u>Administration: \$169,283</u> or 20% of CDBG funding for general program administration costs for staff managing the CDBG program

#### 3. Evaluation of past performance

Funding public service programs has historically been a priority for the City and continues to be a key part of Waltham's CDBG program. Working with these organizations allows Waltham to invest in services that support historically disadvantaged populations and support the CDBG's national objectives. During the 2021-2022 program year (the program year of most recent available data), 4,787 individuals were served with CDBG funds.

In the last year, the Housing Division has seen an increase in the number of individuals seeking assistance for existing affordable housing. During the 2021 – 2022 program year, the City funded 5 housing rehabilitation and rental housing rehabilitation programs: 2 for rental properties and 3 for owner-occupied properties.

Using CDBG funds, the City has been able to fund public facility improvements in public spaces such as playgrounds in addition to buildings providing services to people with disabilities and low-moderate income residents. Specially, the Chesterbrook Apartments (a Waltham Housing Authority property) Roadway Improvements which concluded in 2022 increased accessibility and improved services for low-moderate income residents. Last year, the City received funding for accessibility improvements at Work, Community, Independence Inc., an organization that provides services for people with physical and developmental disabilities and the creation of an ADA universal playground plus an accessible bathroom at a City-owned green space.

#### 4. Summary of Citizen Participation Process and consultation process

Each year, the City strives to solicit citizen input on the creation of the AAP. Many mediums were used to reach out to residents to gather their feedback on potential projects.

Waltham has continued to utilize City social media accounts of Twitter and Facebook to promote all public meetings and outreach activities. Leveraging the many subscribers of these online platforms has proven valuable in casting a wide net to reach the many people that may not see or be aware of postings via traditional outreach methods of local newspaper advertisements or the City of Waltham website. The Planning Department frequently collaborates with members of the IT department for the advertising of all meetings and related programs.

The City engaged in the following outreach activities in anticipation of the PY49 funding year:

<u>Master Plan Special Input Sessions:</u> Waltham is beginning the process of updating the City's Master Plan. As part of this process, Waltham conducted 7 City Council Special Committee Public Input Meetings in each of the City's Wards to solicit input on community development goals including housing creation and barriers to affordable housing. In addition, targeted Master Plan input sessions were held with City Departments, Waltham senior citizens, Waltham veterans, and social service/non-profit organizations. Input meetings will continue in 2023 with the Waltham business community, Boards & Commissions, and schools. The goal of the updated Master Plan will be to identify and address barriers to affordable housing in addition to recommending best practice land use, tax policies, zoning ordinances, building codes, and other community development topics. These meetings began in September 2022 and are continuing into 2023. Comments have been received but are still being evaluated. The data will be compiled for use in the next phase of the process to update the Master Plan. Some of the survey responses were in line with 2020 – 2025 Consolidated Plan goals and PY49 priorities such as investments in the Southern Neighborhood District and the need for social service programs.

- <u>Annual Action Plan First Public Hearing:</u> On January 24, 2023, the Planning Department held the first public meeting for the PY49 AAP and CDBG community development needs. The meeting was advertised via City social media accounts, the City website, and the Boston Globe
- <u>Substantial Amendment Public Hearing</u>: On February 13, 2023 the Planning Department held a Public Hearing on a Substantial Amendment to the PY48 Annual Action Plan and Consolidated Plan to add prior year's unexpended funding into an accessibility upgrades project at Work Community Independence Inc. which is anticipated to conclude before the new Program year 49. This meeting was advertised via City social media platforms, the City website, and the Boston Globe.
- <u>Technical Assistance Sessions</u>: The Planning Department held two technical assistance sessions January 31, 2023 and February 15, 2023 on the CDBG competitive application via Zoom videoconference. These two sessions were organized to provide guidance and information for social service and public organizations - potential applicants of CDBG funding.
- <u>City Council Meetings:</u> The Waltham City Council met March 13, 2023 to review and send the YR49 CDBG program and budget to the Economic and Community Development Sub-Committee. The City Council's Economic and Community Development Subcommittee met March 20 and voted to approve the YR49 program and send to the City Council for approval. On April 10 2023, the Committee as a Whole approved the YR49 CDBG program.
- <u>Final Annual Action Plan Draft Public Meeting Release:</u> The Annual Action Plan Draft Final Edition was released in a Public Meeting via zoom videoconference in April, 10 2023.
- <u>Public Comment Period</u>: In compliance with Waltham's Citizen Participation Plan, each CDBG public meeting follows an accompanying 30-day public comment period. The Planning Department received one public comment for the Annual Action Plan Draft Final Edition meeting.

#### 5. Summary of public comments

Citizens and citizen groups have at least 30 days from every Public Hearing to provide comments to the City. Meetings and directions on where to submit public comments are detailed in the advertisements of public meetings.

Per its Citizen Participation Plan, the City of Waltham considers all comments from citizens, public agencies, non-profit organizations and other interested parties in preparing its final Annual Action Plan submission. The Waltham Planning Department provides written answers to written complaints and grievances within 15 days, where practical. No public comments were specifically received on the first Public Hearing on January 24 2023 or during the Substantial Amendment Public Hearing on February 13 2023. The Annual Action Plan Draft Final Edition meeting received one public comment. This comment and the Planning Department's response is found in AP-26.

#### 6. Summary of comments or views not accepted and the reasons for not accepting them

The Annual Action Plan Draft Final Edition meeting received one public comment which was accepted. The comment and the Planning Department's response is found in AP-26.

#### 7. Summary

The PY49 AAP will be relied on by the City as its guiding document for its administration of the CDBG program for the fourth year of the five-year strategy, accepted by HUD. The Planning Department will continue to welcome comments and inquiries regarding the program and opportunities for community development across the City.

# AP-10 Consultation - 91.100, 91.200(b), 91.215(l)

#### 1. Introduction

Development of the AAP relies on consultation and communication with various partners. Many consultation meetings are held in a round table format, via email, phone conversations, and through video conferences where ideas are exchanged for the purpose of strategizing and leveraging resources. Discussions commonly occur between the City of Waltham and the Waltham Housing Authority (WHA), City of Newton, the Waltham Police Department, the Balance of State Continuum of Care and the WestMetro HOME Consortium. In addition to participation with the above-mentioned public organizations, the Planning Department also consults with multiple social service organizations. These meetings seek to address needs, inform funding decisions, and ensure the provision of critical services via CDBG investments.

# Provide a concise summary of the jurisdiction's activities to enhance coordination between public and assisted housing providers and private and governmental health, mental health and service agencies (91.215(I)).

The Planning Department and Housing Division meet regularly with WHA staff for project coordination for managing active projects in addition to planning out future projects. The City assists with CDBG, HOME, and City capital funds to engage in public facility improvement projects at WHA facilities. The City has managed WHA improvement projects such as a repaving project at Chesterbrook Apartments in 2022, spray park installation at Dana Court Apartments in 2018, and an accessibility upgrades project at Beaverbrook Senior Apartments slated to start construction in 2023 which is utilizing HOME, CDBG, and Commonwealth of Massachusetts High Leverage Asset Preservation Program (HILAPP) funding.

Through participation in the Balance of State Continuum of Care, the City of Waltham works closely with the Waltham Community Day Center, Middlesex Human Service Agency (MHSA) and the WHA to connect homeless and low-income individuals with the resources available throughout the Brookline Newton Waltham and Watertown areas. Additionally, the Planning Department and Housing Division administer CDBG, CDBG-CV, HOME, and City funds to support social service organizations working to provide housing, health, and mental health services.

# Describe coordination with the Continuum of Care and efforts to address the needs of homeless persons (particularly chronically homeless individuals and families, families with children, veterans, and unaccompanied youth) and persons at risk of homelessness.

The City of Waltham is within the Balance of State Continuum of Care (CoC) along with 115 other cities and towns across eastern MA. The Balance of State is responsible for submitting the CoC Consolidated Application for McKinney-Vento funds for homeless assistance programs each year. The City of Waltham supports and participates in the Balance of State application for funding and strives to coordinate CDBG funding goals with attainable targets laid out by the CoC.

The coordinated entry system requirements put in place by HUD in January 2017 have also allowed for a more streamlined approach for assessment of the housing first model. The coordinated entry system assesses individuals and families to entry points and connects them with public and assisted housing providers along with government health, mental health, and service agencies. The City often refers individuals to coordinated entry points.

The City of Waltham participates in the Balance of State/CoC homeless Point in Time Count annually. For this, the Housing Division collaborates with the Waltham Police Department (WPD) Homeless Outreach Team and social service organizations such as the Community Day Center to conduct an accurate count of people experiencing homelessness and relay this information to the MA Department of Housing and Community Development (DHCD).

The WPD deploys a Homeless Outreach Team with the aim to help assist people experiencing homelessness in Waltham via community policing and referring people Waltham to social service organizations, shelters, and treatment centers. The WPD's homeless strategy is modeled after Chelsea, MA's Chelsea HUB program to address homelessness by collaborating between multiple stakeholders such as Newton Wellesley Hospital, the Community Day Center, MHSA, the Planning Department, Housing Division, and more. Lastly, the WPD has a jail diversion staff position and commits people to alcohol/drug abuse treatment centers for those in need of rehabilitation.

The Housing Division manages the Tenant Based Rental Assistance Program which provides funds to Waltham residents to pay for security deposits and first month rent payments directly to the landlord. In 2023-2024, it is estimated that 20 homeless or at-risk Waltham families at or below 60% AMI will be served with TBRA assistance.

The Waltham Community Day Center and MHSA Bristol Lodge in Waltham assign clinical staff to conduct street outreach. Specifically, the Bristol Lodge has an Outreach Specialist that reaches out to unsheltered individuals throughout the City including in wooded areas that are hard to reach. The Bristol Lodge and Community Day Center collaborate with the WPD Homeless Outreach Team to reach out to unsheltered people and to get them off the street and connected to services.

Through the MetroWest HOME Consortium, the City also assisted with the HOME-ARP allocation plan development to help address homelessness in Waltham and Greater Boston.

While the City of Waltham does not receive Emergency Solutions Grant (ESG) funds, Waltham is an active participant in the CoC and supports ESG activities, standards, and consultation processes. In addition, Planning Department and Housing Division staff engage in ESG application review for projects within the former Brookline-Newton-Waltham-Watertown (BNWW) CoC. Social Service organizations within Waltham can access ESG funds through the City of Newton, which administers ESG funding. ESG/Balance of State CoC program updates are detailed in WestMetro HOME Consortium meetings that Planning Department and Housing Division staff attend. Planning Department and Housing Division staff attend strategies for funding.

# Explain how federal funds will leverage those additional resources (private, state and local funds), including a description of how matching requirements will be satisfied

The City leverages a diverse set of funding resources to bolster CDBG allocations. Waltham is a member of the WestMetro HOME Consortium, and receives HOME funds that go towards projects that supplement affordable housing and rental assistance. Often, dollars from several fundings sources will go into projects to effectively fund larger projects. Specifically, the Beaverbrook Senior Apartment ADA upgrades project is utilizing CDBG, HOME and Commonwealth of Massachusetts High Leverage Asset Preservation Program (HILAPP) to make up the project budget. This project, which is using prior year available funds on the 2022-2023 CDBG budget is anticipated to spend out by the end of 2023. CDBG funds are also complemented with local Community Preservation Act (CPA) funding and Municipal Housing Trust funds. In addition, the City also receives Match funding through the Waltham Hosing Authority MVR vouchers annually. Lastly, the Community Preservation Committee sets ten percent of the annual revenue aside for housing projects.

# If appropriate, describe publicly owned land or property located within the jurisdiction that may be used to address the needs identified in the plan

The City of Waltham continues to administer a Section 108 Loan from HUD to test, cap, and revitalize the former municipal landfill, located off Woerd Avenue in the City's Southern Neighborhood District (further discussed in Section AP-50 Geographic Distribution). The project will be to revitalize the former landfill into a park and open space recreational area for residents. Specific project scope items include walking trails, a skate park, and a new playground facility. Portions of the site directly abuts Koutoujian Playground.

The City is also using Housing Trust Funds for the renovation of a City-owned historic property at the former Fernald Development Center site to create two new units of affordable housing. The first phase of the project for exterior renovations is estimated to be finished in the end of June 2023. In March 2023, the City issued approval to use Community Preservation Act funding for the acquisition of land to preserve access to Prospect Hill Park; open space with walking trails and recreation opportunities.

#### Discussion

The City of Waltham continues to seek innovative ways to leverage CDBG funds with other funding sources and partnerships with private and nonprofit entities.

# Describe the reasons for allocation priorities and any obstacles to addressing underserved needs

The City of Waltham will maintain its practice of funding Public Services and Administration within its respective caps of 15% and 20% of total PY49 funding. An additional \$220,000 will also be deducted from PY49 funding for the purpose of satisfying the City's annual Section 108 loan repayment obligation. The remaining PY49 funding will then be distributed between planned Public Facilities activities as well as Rehabilitation Housing Assistance and Rehabilitation of Rental Units.

- Waltham Partnership for Youth Inc. | Youth Career Exploration and Training: \$9,000
  - Waltham Partnership for Youth Inc. provides low-income Waltham youth with career exploration and training opportunities for children between 13 and 19 years old. Partnership for Youth works with employers, educators, and service providers. CDBG funds will go towards supporting costs of programs including internships, mentorship, and training programs.

#### Prospect Hill Community Foundation | Academic Support for Waltham Youth \$9,000

# Description of the geographic areas of the entitlement (including areas of low-income and minority concentration) where assistance will be directed

The entitlement area is interchangeable with the municipal boundaries of the City of Waltham and encompasses approximately 13.75 square miles. While CDBG activities can be permitted anywhere within the entitlement area, subject to these activities meeting a national objective and all eligibility requirements, the City's southern neighborhoods have historically reported higher rates of poverty and low-incomes as well as greater demographic diversity as recorded in the US Census in addition to related federal programs and surveys. In recognition of these populations, and a larger concentration of human and social service agencies, the City has established a Southern Neighborhood District to better highlight the needs of the geographic area. Presently, of the 13 Census Tracts which make up the entitlement area, 7 can be considered part of the Southern Neighborhood District. These tracts are: 3683, 3684, 3685, 3686, 3687, 3688, and 3689.02.

The majority of overall CDBG funds will go towards projects in the Southern Neighborhood District. However, any funding to projects/organizations outside of the Southern Neighborhood District will still target historically disadvantaged populations and LMI individuals and families such as the Chesterbrook Community Foundation, operating out of the Chesterbrook Gardens WHA site. Note, the CDBG Administration funds are included in the 96% of funds to the Southern Neighborhood District as these funds go towards running programs and managing projects in this area.

#### Rationale for the priorities for allocating investments geographically

The Southern Neighborhood District is recognized by the City as a target area due to several combining factors based on data primarily collected and reported by the US Census Bureau. These factors include:

- Eligibility A majority (52%) of the Southern Neighborhood District's population is low- to moderate-income (LMI)
- Over one third of the Southern Neighborhood's population is low-income (37%)
- Precedent (96%) of the overall activities this year are located in the District, and the funded organizations outside of the District still serve those living in the District such as Waltham Partnership for Youth which operate out of Waltham High School and Chesterbrook Community Foundation which serves residents of the Chesterbrook WHA in North Waltham. The Southern Neighborhood District has historically been a target area for the City to invest in due to CDBG

LMI program eligibility and to increase services to the area of Waltham that is more diverse and has a higher percentage of LMI residents.

• Projected Long-Term Need - A majority (±72%) of the City's approximately 938 permanent federal- and state-subsidized housing units are located in the Southern Neighborhood District.

## Discussion

The Southern Neighborhood District has the largest concentration of foreign-born citizens and multifamily dwellings. Further, a majority of the City's affordable housing and public housing units are located within this diverse, multi-family district. The Census Tracts making up the Southern Neighborhood District have been identified based on aggregate income calculated from data made available through the HUD Low- and Moderate-Income Summary Data (LMISD) Map Application.

# AP-75 Barriers to affordable housing -91.420, 91.220(j) Introduction

The City of Waltham, much like all of eastern Massachusetts has experienced year- over-year sustained surges in median home prices. The February 2023 median home listing price in Waltham was \$789,450, versus \$649,900 in February of 2022, which is an increase in over 21 percent (realtor.com). This unaffordability of homes is felt by potential first-time homebuyers, low-moderate income individuals/families, and disadvantaged groups.

The City of Waltham continues to experience barriers to affordable housing, ranging from high land and construction costs to regulatory constraints and economic disparities. While these challenges are shared with neighboring municipalities, Greater Boston, and New England as a whole, the City is fortunate to have strong working relationships with the members of the WestMetro HOME Consortium and the Waltham Housing Authority.

# Actions it planned to remove or ameliorate the negative effects of public policies that serve as barriers to affordable housing such as land use controls, tax policies affecting land, zoning ordinances, building codes, fees and charges, growth limitations, and policies affecting the return on residential investment

City staff have completed an informal assessment of affordable housing barriers and identified several actions to create new affordable housing as well as prevent evictions for low-income tenants. Among these actions are:

- Utilizing City-owned property to create new affordable housing units via building renovations and remodels
- Appropriating Community Preservation Act funds to go towards historic renovation projects that can also support affordable housing creation
- Continuing to provide Rental Assistance and Home Rehabilitation programs for residents
- Allocating a minimum five-percent (5%) of annual building permit fees to increase the annual Municipal Housing Trust Fund, and
- Amending local zoning ordinances to permit certain accessory housing uses and establishing procedures to legalize apartments that were not permitted and/or do not presently comply with building and fire codes

Additionally, the City continues to work closely with the Waltham Housing Authority and the WestMetro HOME Consortium on annual Fair Housing training opportunities with the relevant agencies and

organizations in the area.

### Discussion

Throughout the remainder of the five-year strategy, the City, through its Planning Department and Housing Division, will continue to assess barriers to affordable housing and prepare for changes to future strategies as needed to most effectively respond.

# AP-85 Other Actions - 91.420, 91.220(k)

# Introduction

The City of Waltham has strategically funded projects designed to assist the community, and particularly its LMI residents in overcoming obstacles. The actions listed below are a sample of the numerous actions that can be taken through the CDBG program to support community development.

## Actions planned to address obstacles to meeting underserved needs:

This year's public service funding will directly assist in helping underserved needs of historically disadvantaged populations. Opportunities for Inclusion assists those with developmental and intellectual disabilities. Friends of the Family School, Partnership for Youth, Prospect Hill Community Foundation, the YMCA, Chesterbrook Community Foundation, and the Boys and Girls Club all provide after school enrichment programs for low- and moderate-income children in Waltham. Funding will also go towards the Community Day Center to engage in programs and case management for people experiencing homelessness. CDBG funding will also assist Latinos En Accion and Friends of the Family School to provide ESL training for non-English speakers in Waltham. CDBG funding will also go towards individuals that are food insecure and require financial assistance through both the Hope Kitchen and the Utility Assistance Program through the Salvation Army.

The Planning Department and Housing Division also collaborates with the Waltham Police Department Homeless Task Force, local shelters, and organizations and attend meetings and share resources on addressing homelessness.

Through the WestMetro HOME Consortium, Waltham and member communities will engage in a Fair Housing Testing program in PY49. From the results of this survey, Waltham Planning Department and Housing Division staff will gain quantifiable insight on barriers to housing that housing voucher holders, low income, and minority residents face in the Greater Boston area.

# Actions planned to foster and maintain affordable housing

In order to foster and maintain the existing affordable housing stock in Waltham, the CDBG program will continue to fund the housing rehabilitation program offering zero interest deferred loans to affordable housing owners. This will help preserve the current housing stock. The Planning Department and Housing Division will also work closely with the Waltham Housing Authority to update existing affordable units. The City also utilizes the Community Preservation Act to fund projects that rehabilitate or create properties that have designated affordable units. Lastly, the Housing Division manages the

Tenant Based Rental Assistance program to people in need of emergency housing payment assistance.

### Actions planned to reduce lead-based paint hazards

The City of Waltham will continue to administer its Housing Rehabilitation Loan Fund to owner- and tenant-occupied housing units for various eligible improvements that enhance the occupants' quality of life, including the mitigation of lead-based paint hazards and lead abatement in partnership with the City Public Health department, coordinating delivery to maximize resources.

# Actions planned to reduce the number of poverty-level families

The 2021 American Community Survey 5-Year estimate indicates that nearly one out of every ten (8.8%) Waltham residents live below the poverty level. This is more prevalent among foreign-born residents (13.1%) and elderly citizens (10%). The City of Waltham will continue to allocate CDBG funds to subgrantees primarily in the Southern Neighborhood District that undertake public services directly assisting low-income persons, with particular attention to those living below the poverty level.

# Actions planned to develop institutional structure

In the upcoming Program Year, the Planning Department and Housing Division will develop stronger inter-department collaboration in addition to continued engagement with public service organizations and the WHA. Furthermore, in February 2023, the City received NCDA (National Community Development Association) membership, and in PY49, Planning Department staff will enroll in NCDA trainings.

# Actions planned to enhance coordination between public and private housing and social service agencies

Please refer to Section AP-10 Consultation (91.215(I)).

### Discussion

While the City's Planning Department serves as the local administrator and CDBG project lead, the program's impact and success could not continue without the partnership of local private and nonprofit entities and other government agencies. Specifically, the City and the WHA work with MHSA and the Community Day Center to focus on homeless individuals and increasing access to affordable housing options.

Greetings,

I am a current resident of Waltham and I am concerned that the Waltham Community Leadership Group was not directly consulted or reached out to during the development of the plan to use this grant to improve services for homeless people in Waltham. Speaking to people in the community and visiting that group's meeting, I have learned that homeless people in Waltham don't really have anywhere to go on Sundays or holidays because the Bristol Lodge is closed due to lack of funds. There are also numerous accessibility issues that have not been addressed at the Bristol Lodge which makes it hard for anyone with mobility issues to enter the building. Given that this grant is supposed to address accessibility issues, the Bristol Lodge should be prioritized for funding to fix those issues, as well as to increase its open hours, or find other places that can be open on Sundays to provide a place for homeless folks to rest safely.

Waltham officials need to better canvas the homeless population for input. The report says that so many times there were no public comments, but it is unclear to me how officials advertised the opportunities for comment. Flyers should be put up in the Waltham Community Day center as well as any other places that homeless folks in Waltham go. Additionally, Champlains on the Way and the Waltham Community Leadership Group should be added to any direct outreach lists to give input on these issues since they are working with the community day in and day out and actually put homeless folks in leadership to give direction to addressing their needs.

The first housing summit put on by Waltham Community Leadership Group was a great beginning to addressing our ongoing housing crisis as explained in the action plan draft due to massively increasing rent and land prices in Waltham. I hope Waltham leaders and government officials will continue working with that organization as they plan a second housing summit later this year.

Thank you for contacting the City of Waltham Planning Department and providing your input on the Community Development Block Grant (CDBG) Program Year 49 Annual Action Plan. The City of Waltham is committed to supporting homeless assistance programs. In addition to CDBG funding going towards the Community Day Center and (in years past), the Middlesex Human Service Agency (MHSA), Waltham commits City funds to go towards a winter warming shelter program for unhoused individuals operating out of the Community Day Center.

All public meetings related to the CDBG program are advertised on City social media pages, City website, and newspapers. The Planning Department keeps an active listserv of interested parties that receive emails regarding opportunities, meetings, and updates for the CDBG program. Notably, there are members of the Community Day Center, Chaplains on the Way, WATCH CDC, REACH Beyond Domestic Violence, MHSA, and other social service organizations that are on the CDBG listserv.

MHSA/Bristol Lodge has historically been a recipient of CDBG funds by the City. Bristol Lodge/MHSA did not receive any funds for the upcoming 2023-2024 year because they did not put forth a competitive application for funding. The Planning Department was notified by MHSA in February 2023 that the MHSA would not be applying for funds for the upcoming year. From your comment, the City will look into potential ways to assist the MHSA in addressing its accessibility issues.
