CHANGES, CORRECTIONS AND CLARIFICATIONS

The attention of bidders submitting proposals for the above subject project is called to the following addendum to the specifications. The items set forth herein, whether of omission, addition, substitution or clarification are all to be included in and form a part of the proposal submitted.

ITEM 1: ANSWERS TO POSED QUESTION

- Q1. Can you clarify how the tree trimming should be priced by the Foot, height vs width ect.?

 A1 The item for Tree Trimming is to be measured by the linear foot needed to establish the envelope (width x height) needed for the rail extraction equipment.
- **Q2.** As stated in the Pre-Bid Meeting the Tree Warden will not be marking trees in advance. Is it possible to schedule a walk-through with the Tree Warden before the Bid is due?
- A2. A complete walk thru will be scheduled w/the winning Bidder, in the meantime, interested parties are urged to visit the site.
- **Q3.** Please Clarify Tree Clearing pricing, as it says by the Acre? I know you stated you are looking for minimal clearing as possible, however some areas have grown a lot more in 2 years.
- A3. Though some trees will need trimming only (covered under Tree Trimming item), there are trees growing entirely within the envelope needing to be cleared that will require felling and removal of trees and stumps. The total area anticipated should be calculated.
- **Q4.** In the specs under Tree Protection, can you clarify if we can spread wood chips from the trees we take down?
- A4. Trees felled may be used as wood chips for tree protection; however, the use should be limited to that required for the tree protection, with excess material hauled and disposed accordingly.
- **Q5.** Please clarify along the section of Bacon & Lexington where half of the track is buried under a Concrete wall?
- A5. As noted on the plans, the blocks will need to be removed and reset adjacent to the tracks.
- **Q6.** After removal of the rail/ties, what is the final condition for the rail bed (graded smooth, compacted, rolled)?
- A5. Yes graded smooth.

ITEM 3: ADDITIONAL DETAILS

<u>Change to Limit of Work – Eliminating ROW between Wooden Trestle Bridge and Linden Street Bridge</u>
The project scope of work shall be changed to eliminate the ROW between the Wooden Trestle Bridge to the Linden Street Bridge (sheet 19 & 20). Thus the limit of work shown on Sheet 19 shows the end before the Wood Trestle Bridge (roughly 102). The limit of work would resumes Sheet 20 just west of the Linden Street Bridge, as shown by the limit of work (roughly at 109).
