**CHANGES, CORRECTIONS AND CLARIFICATIONS**

The attention of bidders submitting proposals for the above subject project is called to the following addendum to the specifications. The items set forth herein, whether of omission, addition, substitution or clarification are all to be included in and form a part of the proposal submitted.

**ITEM 1: ANSWERS TO POSED QUESTIONS**

**Q1.** Is the EDI Data Aggregator DA-400 acceptable according to the specifications?

**A1.** The specification requirement and description are for the contractor to provide a single 360-degree camera data detection and aggregation system, and the stop bar passive data including mac addresses, phones, etc. to address corridor information and timing of routes at the three (3) intersections specified. The system is to be from a single manufacturer where any updates of software, hardware, firmware and the like, shall be updated by a single manufacturer. There shall be no functional disassociation, and all of the parts of the system shall be manufactured and meet stringent QA testing by a single manufacturer.

**Q2.** During the warranty period, should we include programming changes that may be done remotely by the manufacturer?

**A2.** The Warranty period is to include ALL Labor and Materials associated with the installation of the three (3) Intersections. No additional charges will be allowed. The specification calls for an additional training session post completion (per specification two months after whole system has been running) that includes adjustments.

**Q3.** Should software and firmware version upgrades be included as part of the bid?

**A3.** Any and all software and firmware upgrades, and all associated labor and materials costs, shall be included in the first year of warranty and shall be included in the bid.

**Q4.** Should technical phone support from the manufacturer be included in the bid?

**A4.** Any and all technical phone support from the manufacturer, and all associated costs, shall be included in the first year of warranty and shall be included in the bid

**Q5.** Will data charges, or reoccurring charges be acceptable for the system? Should they be incorporated into the bid?

**A5.** Any and all reoccurring costs from the manufacturer, the distributor, the vendor or any third-party service that is required to meet the requirements of the project, and all associated costs during the warranty, shall be included in the first year of warranty and shall be included in the bid.

**Q6.** Should the system be capable and operable for data and live streaming with a cap or threshold, based on usage?

**A6.** Refer to the contract documents.

**Q7.** What are the allowed times for Installation of Cameras to not interfere with Traffic patterns?

**A7.** Between the hours of 9am and 3pm

**Q8.** Is Vendor responsible for providing a Bucket Truck or Lift for Installation?

**A8.** Yes
