Q1. What are the Number of Licenses required?

A2. 512 Aruba AP Licenses

Q2. How many runs per Closet (High School)?

A2. **HS 160c = 13**

C108 = 24

Telephone Closet = 34

Closet 7 = 10

Voc Closet 24

Media Center = 19

3rd Floor Closet 52

Q6. Does the City accept only Aruba Access Points?

A6. Yes, we have specified Aruba Networks AP-105 with ceiling mount hardware

Q7. What is acceptable: Ceiling mounted plate or RJ45 Keystone?
