ITEM 1: ANSWERS TO POSED QUESTIONS

- **Q1.** Scope of Services item #3.B.6 requires "Construction oversight during the entire construction period". However Task 5 on the Cost Evaluation Form calls this "Construction Inspections/Oversight". What is the level of effort/coverage the City wants during construction?
- A1. No less than weekly 2-hr visit
- **Q2**. Can you clarify what Scope of Services item 3.A.6 means relative to Lincoln, Dale, Beaver and other surrounding roadways?
- **A2.** There is no scope of service for these locations
- **Q3**. Section V.3- asks for name, address, contact,etc. For "all private sector clients to which the proposer has provided similar design services...". This would be a major undertaking for any long established firm. What is the City looking for here?
- A3. Include no less than your best 3 RELEVANT references
- **Q4**. Will the City be able to furnish crash and/or traffic count data for this intersection?
- **A4**. See report in the link below.

- **Q5.** Will the previous studies for the intersection (performed by the City's private Master Plan Consultant be provided?
- **A5.** Available, but not relevant to the scope of the project
- **Q6**. The traffic design described in the Scope of Service (items III.A.1 through III.A.4 and III.A.6) could be prepared with the dimensions obtained during the Survey Review (Task 1 as described in Addendum 1); however, a full civil/roadway design as described in paragraph III.A.5 would require a detailed topographical survey (which is not mentioned in the RFP) and may be a challenge to provide in the 60-day time limit established in paragraph III.B.7. Please clarify what is meant by "recommendations" in paragraph III.A.5 and describe the City's expectations for the civil/roadway portion of the design.
- **A6.** The City is not looking for a full topographical survey. The survey intended here is to take curb -to-curb measurements
- **Q7.** Are infrastructure improvements at the adjacent intersections described in paragraph III.A.6 included in the scope?
- **A7.** NO
- **Q8**. How many design submissions will be required and how much time should be budgeted for each City review period?
- **A8**. Please submit 3 copies of your submission. The City does not intend to have stage review of the proposal
- **Q9.** Are existing signal timing plans and/or traffic counts available for the subject intersection or any of the adjacent intersections mentioned in paragraph III.A.6?
- **A9.** See attached link
- **Q10**. The site is a HSIP crash cluster. Has a road safety audit been performed?
- A10. See attached link
- **Q11.** Does the construction oversight include full-time, on-site resident engineering during construction or only periodic inspections?
- **A11.** The City expects no less than weekly 2-hr site inspections including participating in any weekly construction meeting.
- **Q12.** Should the cost evaluation be submitted as part of the technical proposal or in a separate sealed envelope?
- **A12.** No, Submit with your qualifications
