A) Delete on Page 7-31 - "701.150 Cement Concrete Drives, Aprons and Ramps" **and**

Replace with - "701.150 Cement Concrete Drives and Aprons"

B) Under Section 8 - MISCELLANEOUS DETAIL DRAWINGS Figure Name: 4" /6" CEMENT CONCRETE SIDEWALK; Delete "6" (APRONS/RAMPS)" and Replace with "6" (APRONS)

ITEM NO.: 2 **ANSWERS TO POSED QUESTIONS**

Q1 What Streets will be paved as part of this Contract?

A1 The following is the list of Streets that have been approved with funding by the City of Waltham. Additional streets may be added at a later date. Streets may be deleted too.

Beaver Street (Forest Street to Waverly Oaks Road),

Lexington Street (Bacon St to Main Street)

Vernon Street

Winter Street (First Ave to Lincoln Line)
Wyman Street (Smith Street to Off Ramp)
Plympton Street (Bacon Street to Upland Road)
Dorchester Street
Ellison Park (Main Street to Summer Street)
Gordon Street
Grant Street
Harland Road
Hawthorne Road
Hobbs Brook Road
Irving Street
Liberty Street
Summer Street
Albemarle Road
Ash Street

Q2. Do we know which streets are being done at night.

A2. The only streets we are planning on doing at night are Wyman Street, Winter Street, and possibly Lexington Street. Night work has to be approved by the Chief of Police.

Q3. Is there a take off of anticipated quantities of curb and sidewalk on daytime streets versus night time streets?

A3. There is no sidewalk work or curb work anticipated on Winter Street or Lexington Street. We will be installing new curb, but no sidewalk work on Wyman Street. There are no takeoffs.

Q4 Camera items are very big money if used. Since you've indicated that it's not your intention to use them can a corrected more realistic or token quantity be inserted on the bid form?

A4. The City does not anticipate needing any Camera work. However, in the event that such need will arise please make the following changes:

- Change Item 819.840 from 10 EA to 1 EA.
- Change Item 819.850 from 20 EA to 1 EA.
- Change Item 819.860 from 2,400 LF to 10 LF
