ITEM 1: ANSWERS TO POSED QUESTION

Q1: Would the City agree that with the local, State, and potentially Federal permitting related to wetlands and waters of the U.S. that it would be advantageous to provide a Certified Wetland Scientist or Certified Professional Soil Scientist as part of the proposed team?

a. In addition to the information provided in the RFP regarding the Commonwealth of Massachusetts's Environmental filing for the communities of the Mass Central Rail Trail – Wayside Branch, the PDFs of the Expanded Environmental Notification Form & Appendices along with the MEPA Site Visit Presentation and MEPA Certificate are all posted. As each community advances the design for their segment of the shared use path, it is the expected that local approvals will be required. This project has a lot of support locally and from the Commonwealth of Massachusetts. When the DCR advanced the EENF for all the communities along the Wayside Branch it removed a real hurtle for the overall project.

As stated in the RFP, there is some survey information that the DCR can share that was used to develop the EENF (see p.42 Project Description for possible limits of information). In addition, Exhibit B Central Massachusetts Rail Trail Feasibility Study, 1997 provides some detailed information on each community's segment.
