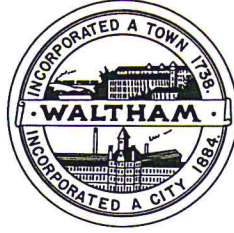
Signs are permitted for a period of one week or less.

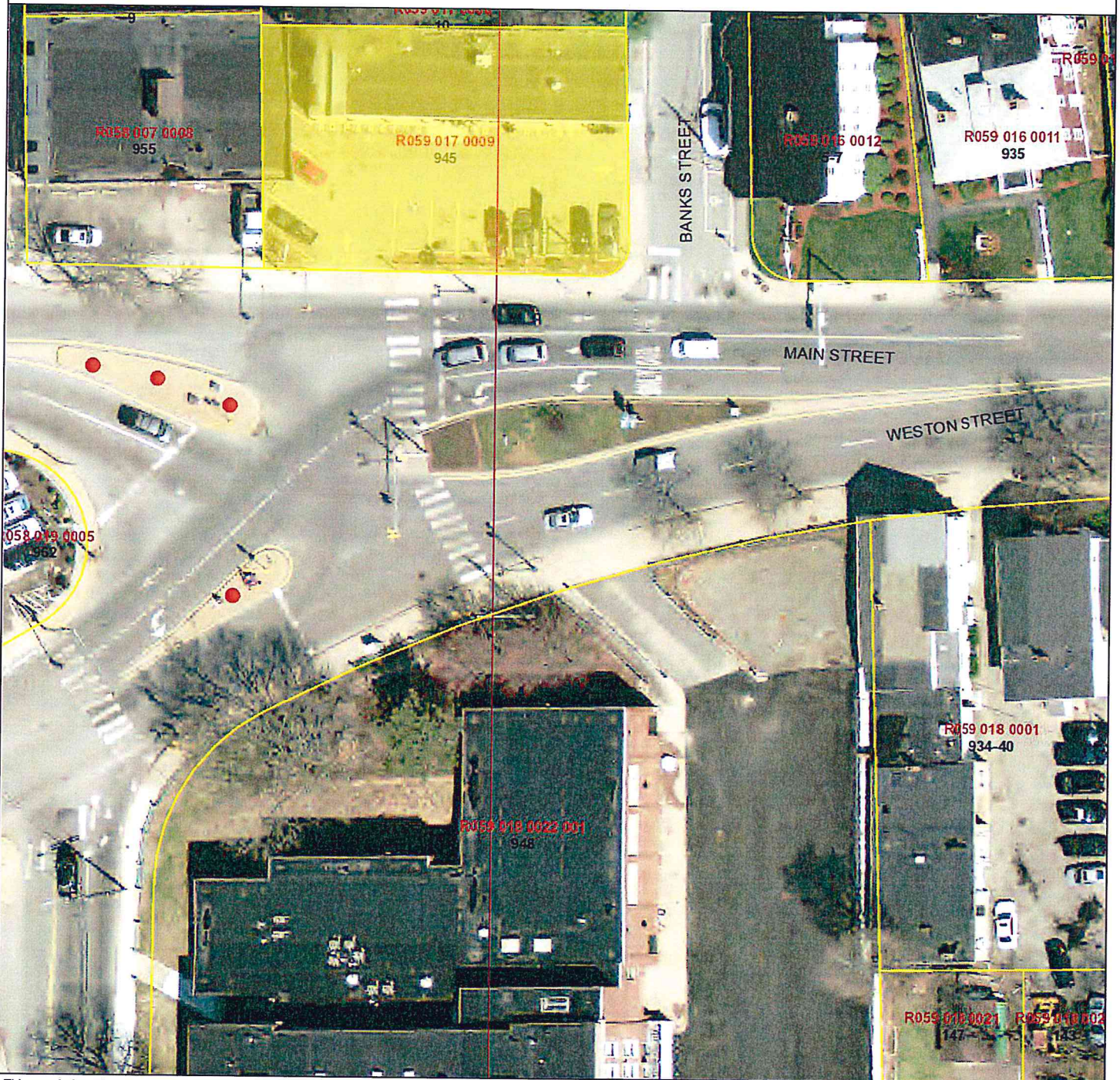

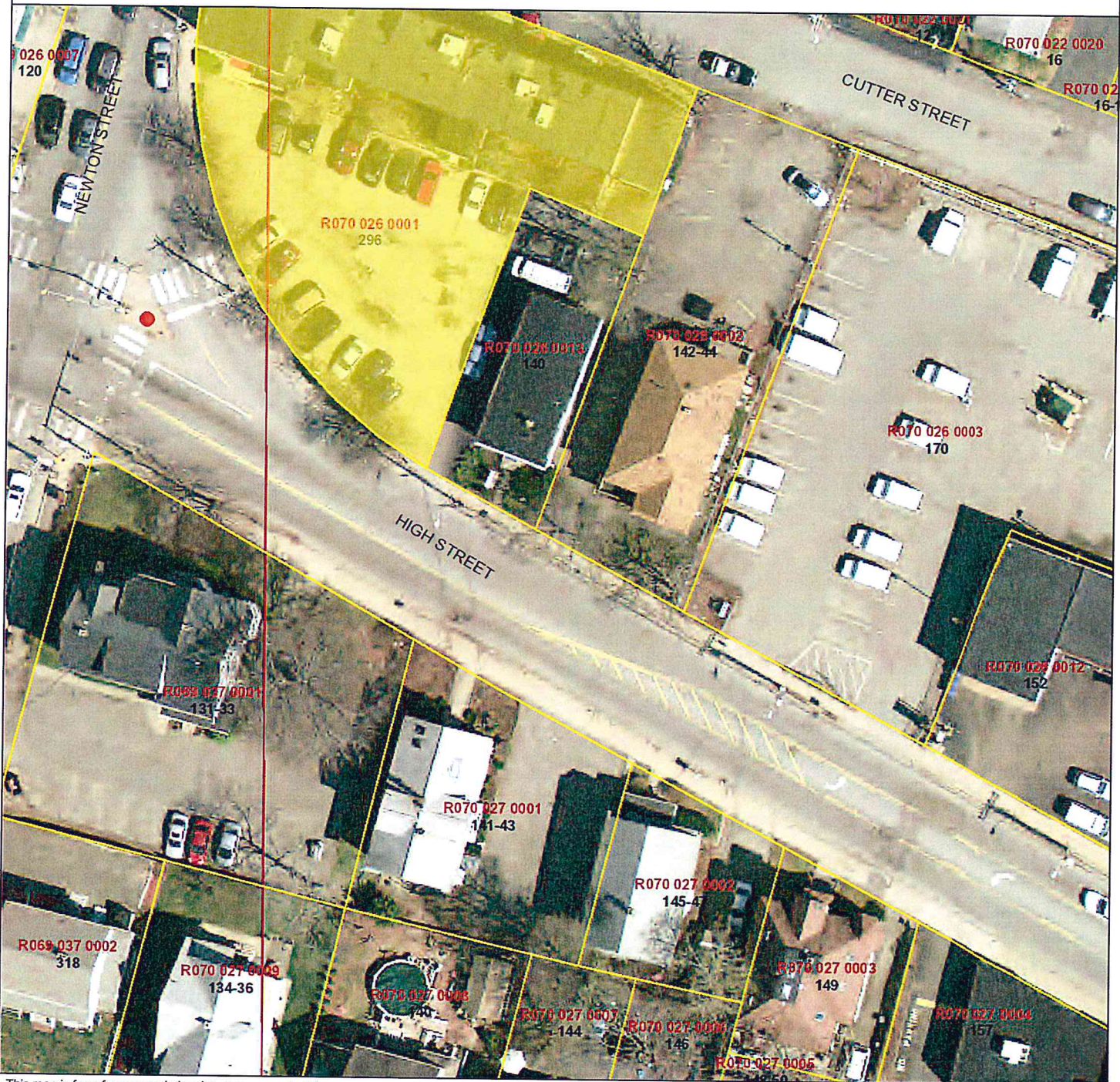

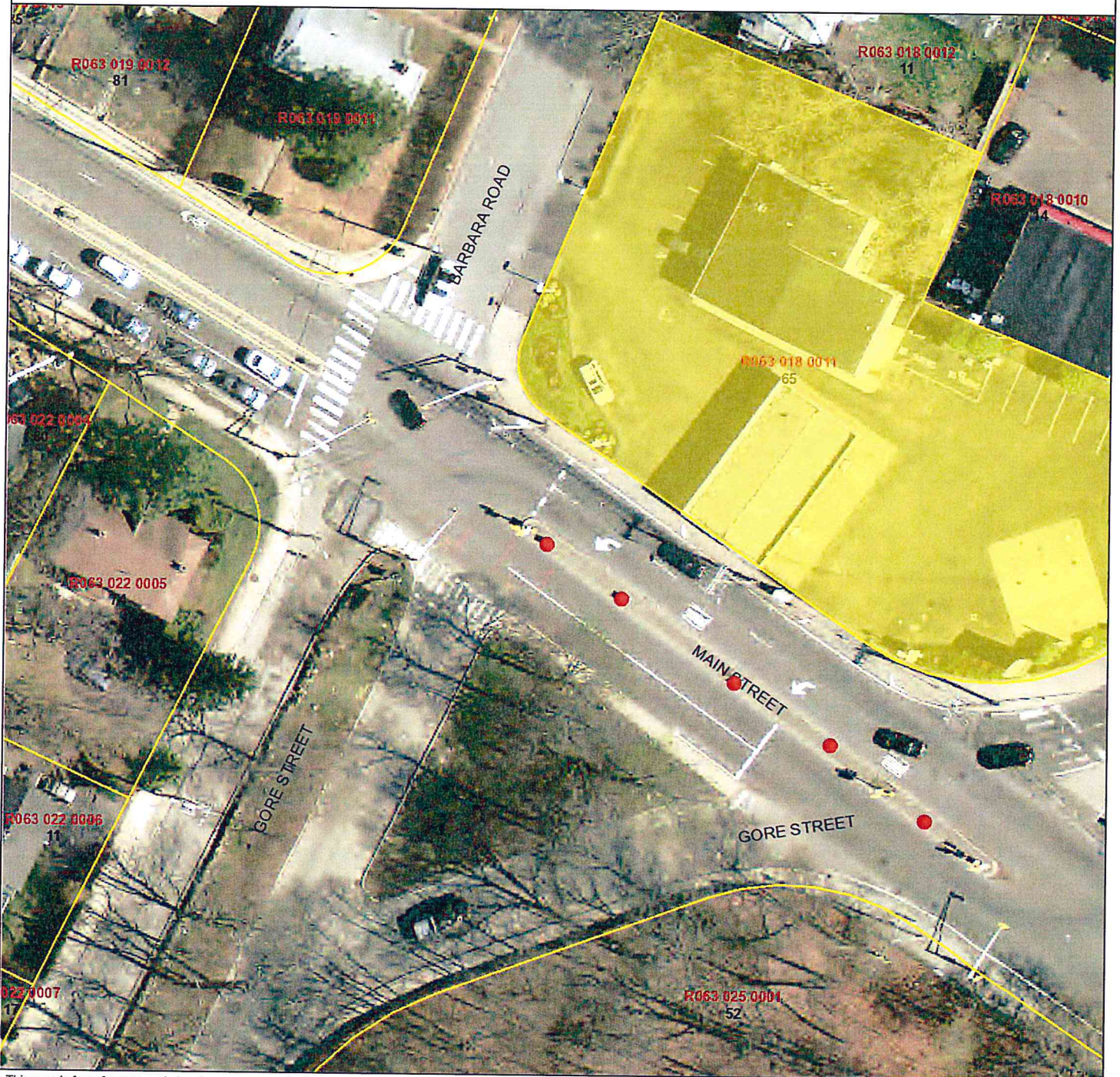
